AN ORDINANCE AMENDING THE WATERFRONT REDEVELOPMENT PLAN OF THE BOROUGH OF SAYREVILLE, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

**WHEREAS,** the Sayreville Economic Redevelopment Agency ("SERA") has designated Sayreville Seaport Associates Urban Renewal, L.P. ("SSA") as the designated redeveloper of a portion of the Sayreville Waterfront Redevelopment Area ("S.W.R.A."); and

**WHEREAS**, the Sayreville Borough Council adopted the Waterfront Redevelopment Plan ("the Redevelopment Plan") dated January 1999 to guide the redevelopment of the S.W.R.A.; and

**WHEREAS**, the Redevelopment Plan was amended on August 21, 2006 by Ordinance No. 951-06 (which was subsequently repealed), on February 9, 2009 by Ordinance No. 76-09, on April 8, 2013 by Ordinance No. 214-13, and on July 22, 2019 by Ordinance 458-19; and

**WHEREAS**, during the redevelopment of the S.W.R.A., it is anticipated that new streets will be constructed; and

**WHEREAS**, through collaborative process among the Sayreville Veterans Alliance, SSA, SERA and the Borough, a process for naming streets has been agreed upon; and

**WHEREAS**, this amendment to the Sayreville Waterfront Redevelopment Plan is intended to memorialize and codify that street-naming process; and **WHEREAS**, SERA has reviewed and supports this proposed amendment to the Sayreville Waterfront Redevelopment Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SAYREVILLE, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY THAT THE TEXT CONTAINED WITHIN THE REDEVELOPMENT PLAN SHALL BE AMENDED AS FOLLOWS:

- I. Part of Paragraph 7 on Page 21 of the Redevelopment Plan, within the Off-Street Parking and Circulation Section, shall be amended as follows (insertions are indicated by underlining thus; deletions are indicated by brackets and strikethrough [thus]):
  - 7.... Street names, <u>except as set forth below, shall</u> be chosen from the list of Veterans maintained by the Borough. <u>Street names for streets within Parcel B and Parcel C shall be determined as follows:</u>

#### **Street Naming Process for Parcel B and Parcel C**

The Riverton Street Names Schematic Map is annexed hereto as Schedule A. Although the exact street layout is subject to modification as part of the site plan and subdivision process, the Riverton Street Names Schematic Map is illustrative of the protocol that shall be employed when naming the streets within Parcel B and Parcel C, which is as follows:

- 1. Names of streets located entirely within residential neighborhoods ("Residential Streets") shall be chosen from the list of Veterans maintained by the Borough and approved by the Veterans Alliance pursuant to Borough Code Section 13-3.2. In selecting names for Residential Streets from that list, the Veterans Alliance shall consult in advance with the designated redeveloper and shall use good-faith efforts to address any concerns or considerations expressed by the designated redeveloper about specific Residential Street names. After consultation, the final decision shall rest with the Veterans Alliance. (For illustrative purposes, planned Residential Streets on Parcel C are shown in grey on the Riverton Street Names Schematic Map, although the final configuration of streets shall be subject to change based on final project design and approvals.)
- 2. <u>Streets other than Residential Streets shall be named in a manner that reflects their general place, order, location, historical reference or project identification, as determined by the designated redeveloper (subject to approval by the SERA Board) in accordance with the following guidelines:</u>
  - a. The parallel streets running roughly east to west on Parcel C (shown in yellow on the Riverton Street Names Schematic Map) shall be named as indicated: South Avenue, 1st Avenue, 2nd Avenue, 3rd Avenue and 4th Avenue. Those east-west streets shall also be given secondary names

to honor Sayreville Veterans who have been awarded Silver Stars, in accordance with records maintained by the Veterans Alliance.

- b. The gateway roadways that provide connection to the Main Street Extension, Chevalier Avenue, Garden State Parkway, and that ultimately will connect under Garden State Parkway to Parcel B and through Parcel B to SR35 (which roadways are shown in orange on the Riverton Street Names Schematic Map) shall be named Riverton Boulevard and Riverton Crossing or such other similar name that reflects the name and branding of the overall development.
- c. The gateway roadway showing in blue on the Riverton Street Names
  Schematic Map, connecting to Main Street Extension and Garden State
  Parkway, shall continue to be identified as Peter Fisher Boulevard to
  reflect Sayreville's history.
- d. The streets running roughly north to south (shown in green on the Riverton Street Name Schematic Map) shall be named in a manner that is reflective of place, direction, historical reference or project branding. Preliminary proposed names are as reflected on the Schematic Map: Waterfront Way, Market Street and Brick Street.
- e. The Main Street Bypass extension (shown in brown and labelled "Crossman Road North" on the Riverton Street Name Schematic Map) shall be named by the Borough to be consistent with the remainder of the Main Street Bypass once constructed.

The waterfront walkway to be constructed on Parcel C shall be designated as "Heroes Walk" as reflected on the Riverton Street Name Schematic Map. The designated redeveloper for Parcel C shall collaborate with the Veterans Alliance to identify at least three (3) ways to honor Veterans and to celebrate the military service and sacrifice of Sayreville's families along Heroes Walk.

At this time Mayor Kilpatrick opened the meeting to the public for questions or comments on any and all matters.

Those appearing were:

- Arthur Rittenhouse, 33 Delikat Lane

Mr. Rittenhouse stated they are having their 3<sup>rd</sup> Annual Shade Tree Art Contest on March 27, 2020. He also stated that the Shade Tree Commission have not been receiving their finance reports on a monthly basis.

Mr. Rittenhouse stated he filed an OPRA request to find out what permits were filed with the Borough pertaining to Fulton's Landing. He stated they have been doing a lot of work and no permits have been filed. Mr. Rittenhouse stated that they there was a hazardous material dumped there in 2017 and it is imperative that we find out if it was removed. He requested the Mayor and Council to look into it.

Mayor Kilpatrick asked the Borough Attorney to look into it.

#### - Pat Bodak, 8 Cheyenne Drive

Ms. Bodak questioned if there is any oversight regarding the cable companies in this town.

Mr. Frankel responded that he hasn't been getting a response from Cablevision and he contacted the BPU which they found out that BPU doesn't have jurisdiction over the cable companies anymore and it's under congress. He stated that he reached out to Congressman Pallone's office and they are looking into it. He stated the other options residents have is to go to satellite and streaming services. He stated he has contacted Cablevision's corporate offices and have not received a response.

Ms. Bodak stated that she spent four hours on the phone with Optimum with no resolution and contemplated calling News 12 NJ and getting Kane in my Corner to do something about this nonsense.

Mayor Kilpatrick stated she hasn't had a house phone for about three weeks and contacted Optimum and then when someone answered she was disconnected.

#### - Ruth Ann Mahoney, 2 Gerard Place

Ms. Mahoney inquired about moving the parking on North Ernston Road.

Council President Novak stated the ordinance was passed.

Ms. Mahoney then questioned the parking in front of the bank.

Mayor Kilpatrick stated that she will refer it to Sgt. Braile.

Councilman McGill stated that where the crosswalk is that they are going to get solar powered caution lights and use a different kind of reflectorized paint on the street.

#### - Randy Litz, 99 Main Street

Mr. Litz stated that he has a parking problem with people with parking in his driveway. Mayor called up Sgt. Theile.

Sgt. Theile stated he will speak with Sgt. Braile and contact station command to make sure that they can regularly patrol that area.

#### - Joseph Ambrosio, SAA Counsel

Mr. Ambrosio stated when the issue first came before the council about their tax issues and 501C they reacted very aggressively to address this situation.

#### - Christina Davis, 92 Miller Ave.

Ms. Davis questioned Ord. #490-20 regarding the financial statement requirement being removed.

Jerry Ust stated after review of the ordinance and other organizations that it is a burden for them to pay over \$1000 for it.

Ms. Davis stated that the Mayor & Borough Council wanted to keep an eye on these municipally sponsored organizations because the town is giving them money and doesn't see how removing that out of the ordinance is going to benefit anyone.

Mayor Kilpatrick stated they still have to submit those but just doesn't have to be by an accounting firm.

Ms. Davis questioned why section "f" is being removed and how and when would taxpayer money be distributed to the municipally sponsored organizations.

Mr. Ust responded the equation that is used is the number of kids registered to each organization and amount of \$28-\$30 per kid, but there is a lot of things that goes into the equation. He stated the Borough does different things at different levels for different organizations so that also determines the reimbursements.

Ms. Davis questioned Ord. #491-20 about the fees that there is an omission of Section a.1, a.2 and a.4. She also questioned the removable of the ordinance that the fees shall not be applicable to municipally sponsored organizations.

Mr. Ust stated all municipally sponsored organizations are exempt from fees.

Borough Attorney DuPont stated they met with Green Acres and they reviewed our ordinances, schedules, permitting process and found it to be reasonable. She stated that we are now charging for Green Acres fields.

Mr. Ust stated that we were the only town that didn't charge for use of Green Acres fields.

Ms. Davis stated a.4 was missing.

Mr. Ust stated that it was removed.

Ms. Davis questioned Ord. #492-20 regarding Borough residents shall have priority use regarding all athletic fields not funded by Green Acres Program is being removed.

Mr. Ust responded it's being removed.

#### - Pav Pervan, 1704 Pebble Place

Mr. Pervan stated that they paid a certain amount of money for winter training for U8 and U10 boys at the fields in East Brunswick. He stated they were kicked out of the fields on their 3<sup>rd</sup> week there by Ms. Davis and her husband. Mr. Pervan stated that she called two police officers to the field. He stated he hired an attorney and filed a demand letter on behalf of the parents of those boys to get the money back from SSC. He stated the reason is that they were promised to have the fields and play there and then were denied service. Mr. Pervan stated that if it is not resolved he will file a class action lawsuit.

Councilman McGill questioned if there were monies involved.

Mr. Pervan responded that they paid \$550.00 for the whole season.

Councilman McGill asked how much total monies are they talking about.

Mr. Pervan stated a lot of money. He stated that he met with Christina Davis outside and asked for the money and she stated it wasn't the time or place to discuss the matter.

He stated they had parents while entering the facility, have them sign a paper stating they were either playing for Sayreville AA or Sayreville Soccer Club which has no relevance.

#### - Christina Davis, 92 Miller Avenue

Ms. Davis stated that Mr. Pervan failed to mention was that prior to their practice on that day an email was sent out notifying them that practice was cancelled. She stated the practice was cancelled because the club became aware of some activities that they deemed inappropriate. She stated that parents showed up with their children despite being told that practice was cancelled. She stated the police came and told them that they are allowed to come to practice next week once the issue was resolved which was bringing players from other organizations that are not part of Sayreville Soccer Club. Ms. Davis stated the U8 and U10 teams decided on their own not to show up to their practices and the field is still reserved for them.

Councilman McGill stated children are involved and a lot of adults. He requested an accommodation be met.

Ms. Davis stated that there is one organization that is able to throw up a new club with no skip on time and want everyone to register with them by slandering another one. She stated she is looking for access to parks in the town they live in.

Borough Attorney DuPont stated that they asked Green Acres to review our policies and they told us that we are able to give those entities or individuals that are municipally sponsored preference. He stated that the Sayreville Soccer Club in the demand letter is being asked to return the \$550 per player.

Ms. Davis stated that amount covers the fall season, winter/indoor practice space as well as spring season. She stated that out of that money they have already paid for spring training upcoming.

Councilwoman Maher asked if the other team's money was returned.

Ms. Davis responded yes that the money was returned because they didn't start their season and no fees were deducted.

Councilwoman Maher asked to return 2/3 of it.

Ms. Davis stated they signed a contract for a full year.

Councilwoman Novak questioned if they were trying to bring in kids that didn't pay the fee.

Ms. Davis responded yes but they weren't looking for a fee because when you are trying out it isn't expected to pay a fee, but they were bringing kids that were trying out for Sayreville AA during Sayreville Soccer Club's paid time.

Mayor Kilpatrick read a letter from Congressman Pallone's office into record announcing 4.1 million dollars has been included into the Army Corps. work plan to finally dredge the Cheesequake Creek.

#### - Bill Lockwood, Lockwood Boat Works

Mr. Lockwood stated after hearing about the money to be allocated for the dredging but one of the things that needs to be addressed is the jetty.

#### - Morgan Marina

He thanked the Mayor and Council for their hard work and there is still a lot that has to be done.

#### - Ed Garbie, Misty Morn

He stated the last time the creek was dredged was 31 years ago. He thanked the Lockwood's and everyone for getting this done.

#### - Edna Ochenge, 2011 Ridgeview Court

Ms. Ochenge stated that she received a picture of the fees for soccer based on 13 kids. She stated the registration fees based on 13 kids was \$7,150.00, \$228.00 for credit card fees, \$240.00 for players and coaches insurance, \$260 for Sayreville Complex field and upkeep, \$2,800.00 for trainers, \$1,200.00 for winter indoor facilities, \$200.00 coach's child discount, \$250.00 for league fees and \$600.00 for ref fees. Ms. Ochenge stated that SSC wanted them to sign papers when they arrived at the East Brunswick field that they belong to Sayreville SSC and if not then they can't be there. She stated that once you turn my child away once that she won't let that happen again.

Mayor Kilpatrick stated that this is one of the saddest things she ever witnessed. She stated she has never seen in her life the conduct and the behaviors of adults turn around and cause this lasting damage to kids. Mayor stated that the kids are there to have fun. She stated that this is disturbing and an embarrassment to this community. She recommended that the adults get it together and these organizations will do what's right for these children.

- Jonasz Knapik, 47 Highland Street

Mr. Knapik stated he was Vice President of Sayreville Soccer and now is running soccer for Sayreville AA. He stated that recreation represents about 80% of the soccer program in town. He stated there will be a good program for the kids and head in the right direction.

Mayor Kilpatrick stated the kids are aware of what is going on and not enjoying it.

- Ruth Ann Mahoney, 2 Gerard Place Ms. Mahoney stated it's time to grow up, think about the kids and put it aside. She stated this is very sad.

Mayor Kilpatrick called for a Motion. **Council President Novak made a motion to close the Public Portion. Seconded by Councilman Dalina.**
