Questioned the figures for the Turf Fields and Lighting project. Looked like the project would be over \$2 million dollars and it was mentioned that it would cost over \$4 million dollars for the whole project. Mr. Kronowski stated that the resolutions spoke about earlier does not include the site work only the materials. Such as the improvements to the stands, and buildings. Councilman Melendez said that the cost for the entire project is \$4.3 million dollars. That includes two fields, lighting, and other improvements such as bathrooms, parking and bonding fees.

Jim Robinson felt this was an excellent project, but reminded the council that this capital project would have to be referred to the Planning Board in accordance with NJSA40:55D-31 which requires that prior to the expenditures to any amount of money a project like this needs to be referred to the planning board for pubic comment and input. Councilman Melendez stated that a public hearing and comment period was held when allocating the money through the ordinance. The Borough Attorney said that he would look into the requirement through State Statute.
