[Co. Henry, Planning & Zoning Committee – Public Hearing, April 23, 2012]

At this time Acting Mayor Eicher opened the meeting to the public for questions or comments on Ordinance #181-12.

No one appeared.

Councilman Henry moved the Public Hearing be closed and the Ordinance adopted on second and final reading and advertised according to law.

ORDINANCE #181-12 AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XIX OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF SAYREVILLE

BE IT AND IT IS HEREBY ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the county of Middlesex, that the Revised General Ordinances of the Borough of Sayreville are hereby amended as follows:

19-1. DEFINITIONS.

As used in this Chapter:

Barrier. A fence, wall, building or combination thereof which completely surrounds the swimming pool and obstructs access to the swimming pool.

Residential. That which is situated on the premises of a detached one or twofamily or a one-family townhouse not more than three stories in height.

Swimming Pool. Any structure intended for swimming or recreational bathing that contains water over 24 inches deep. This include in-ground, above ground, and on ground swimming pools, hot tubs and spas.

Wading Pool shall mean artificially constructed pools not designed or used for swimming, with a maximum area of one hundred (100) square feet and a maximum water depth of twelve (12") inches. This Chapter shall not cover wading pools which are portable.

19-2. **PERMITS.**

19.2.1 Permit Required.

- No person shall establish or construct or alter a swimming pool without first having obtained a permit therefore in the manner prescribed in this article.
- (b) No permit shall be required for any portable pool less than twelve (12) inches in water depth at any point and with a water surface area of less than one hundred (100) square feet.

19.2.2 Application for Permit.

Applications for the permit specified in Section 19-2.1 shall be made to the construction official and zoning officer, on forms to be supplied, by the owner of the property or an accredited agent. The application shall be accompanied by two sets of:

- (1) A plot plan showing property lines of the premises on which the private swimming pool is to be located, all existing houses and structures thereon, the location and dimensions of the proposed private swimming pool or alterations, remodeling or additions thereto, and the distances between the nearest public road and the private swimming pool, septic system (if applicable) on the property, and water, gas and other underground utility lines. The plot plan may be drawn by the property owner or architect, engineer or surveyor.
- (2) Plans and specifications for the proposed swimming pool and all auxiliary structures and appurtenances related thereto and the location and height of the fence or wall, if required, together with the gate and its locking device.
- (3) Permits, plan review and subsequent inspections will be conducted in accordance with Borough Ordinance, New Jersey Uniform Construction Code, and International Residential Code (New Jersey Edition).

Permits for excavations on either public or private property shall not be issued unless the applicant presents a written statement of compliance with N.J.S.A. 2C:17-4, concerning underground gas pipes.

19.3 - TESTS.

Bacteriological samples may be collected from any swimming pool by order the Middlesex County Health Department as contracted by the Borough of Sayreville. These bacteriological samples shall be tested at the expense of the owner of the swimming pool.

19-4 - LOCATION.

- a. No swimming pool shall be constructed or installed in a front yard as the term "front yard" is defined in the Zoning Chapter of this Code. On a corner lot as the term "corner lot" is defined in the Zoning Chapter, no swimming pool shall be constructed or installed nearer to the side street line than the minimum number of feet required for the width of the side yard of the street side of such lot.
- b. No swimming pool shall be constructed or installed nearer than ten (10') feet to any property line of the property on which the pool is located.
- c. No private swimming pool or wading pool shall be constructed or installed on any lot unless a residence building is located on the lot, as permitted in the Zoning Chapter.

19-5 - FENCES, WALLS AND GATES.

- (a) All private swimming pools or additions thereto shall be completely enclosed by a substantial, self-supporting fence or wall of brick, stone or masonry material which meets the approval of the construction official and zoning officer. The fence or wall shall be at least 48 inches above grade and the bottom of the barrier shall be 2 inches. The barrier shall be so constructed as not to have openings that allow passage of a 4 inch diameter sphere. A building may be used as part of such enclosure. Barbed wire shall not be used as fencing. In no event shall the fence or wall be constructed in such a manner or way as to be in violation of any existing ordinance or regulation of the International Residential Code.
- (b) All gates used in conjunction with the fence or wall shall meet the same specifications as the fence and wall and shall be equipped with a self-engaging lock or latch. The gate shall be locked when the pool is not in use or properly supervised.

(c) Spas or not tubs with a safety cover which complies with ASTM F 1346 shall be exempt from these provisions.

19-6 - PORTABLE POOLS.

This Chapter shall not apply to or prevent the installation of portable swimming pools which can be set up wholly above the ground, without the construction of a foundation or permanent extensions to the water or sewer systems of the Borough.

Portable pools shall be maintained in a safe and sanitary manner and shall not be an annoyance or nuisance to adjacent property owners or a hazard or danger to the persons using the pool or to any members of the general public likely to come upon the premises where the portable pool is erected and in operation. The owner of the pool shall provide facilities and appliances to render the pool safe and sanitary at all times.

19-7 - ELECTRICAL INSTALLATIONS.

All electrical installations in connection with a swimming pool shall be installed in accordance with the New Jersey Uniform Construction Code and the National Electrical Code. The electrical subcode official or the electrical inspector shall inspect and approve all installations. No such installation or altered installation shall be placed in operation until the construction official has confirmed that such inspection has been made.

19-8 - ENFORCEMENT.

Private swimming pools shall comply with the requirements of all health authorities having jurisdiction in the Borough. A nuisance or hazard to health which may exist or develop in consequence of the operation of a pool shall be removed by the person in possession of the pool or receipt of notice from the Middlesex County Health Department, Police Department, Code Enforcement Officer, Zoning Official or Construction Official.

BE IT FURTHER ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, that **Chapter Nineteen-Swimming Pools**, of the Revised General Ordinances of the Borough of Sayreville, shall also be amended to reflect said change.

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed and this Ordinance shall take effect immediately upon final passage and publication in accordance with law.

Councilwoman Novak said that it's not fair to the resident taxpayers because the biggest users of water & sewer are businesses, the bill has to get paid and by putting the charge through taxes it would be hurting the residents.

ORDINANCE #182-12

AN ORDINANCE TO SUPPLEMENT AND AMEND CHAPTER XIV, "WATER & SEWER", SECTION 49, SCHEDULE A, SEWER USER CHARGES OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF SAYREVILLE, 1986, AS SUPPLEMENTED AND AMENDED

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Sayreville that chapter XIV "Water & Sewer", Section 49, Schedule A "Sewer User Charges" is hereby supplemented and amended by deleting and inserting in lieu thereof, the following amended Schedule A:

SCHEDULE A SEWER USER CHARGES

Class A Users Discharging Normal Domestic Sewage. All Class A users of the Borough of Sayreville sanitary sewer system discharging normal domestic sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of twentytwo dollars and ten cents (\$22.10) per thousand cubic feet of water consumed.

Class B Users Discharging Non-Domestic Industrial Wastes. All users of the Borough of Sayreville sanitary sewer system discharging other than normal sewage shall be billed quarterly as follows:

- For Middlesex County Utilities Authority (MCUA) charges based on the ratio of the actual flow and actual flow parameters of each Class B user to the total actual flow and total actual flow parameters from the Borough to MCUA using the billing rates prescribed by the MCUA at the beginning of the year.
- For Borough of Sayreville charges based upon the actual flow of each Class B user at a rate of two dollars (\$2.00) per thousand gallons.

Actual flow shall be established based on sewage flow where metered or water consumption where un-metered.

Billing procedures for Class B users shall be more specifically described in Schedule B of Article IV Industrial Wastes of the Borough of Sayreville Code.

Class C Users Discharging Non-Domestic Sewage.

All Class C users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of fifty-eight dollars and thirty cents (\$58.30) per thousand cubic feet of actual sewage flow where metered or actual water consumption where un-metered.

Class D Users Discharging Non-Domestic Sewage.

All Class D users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of forty-eight dollars and sixty-five cents (\$48.65) per thousand cubic feet of actual sewage flow where metered or actual water consumption where un-metered.

Class E Users Discharging Non-Domestic Sewage.

All Class E users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of sixty-five dollars and ninety cents (\$65.90) per thousand cubic feet of actual sewage flow where metered or actual water consumption where un-metered.

Class F Users Discharging Non-Domestic Sewage.

All Class F users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of ninety-four dollars and eighty cents (\$94.80) per thousand cubic feet of actual sewage flow where metered or actual water consumption where un-metered.

Class G Users Discharging Non-Domestic Sewage.

All Class G users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of thirty-three dollars and ninety-five cents(\$33.95) per thousand cubic feet of actual sewage flow where metered or actual water consumption where unmetered.

Class H Users Discharging Non-Domestic Sewage.

All Class H Users of the Borough of Sayreville sanitary sewer system discharging sewage with flow parameters in excess of normal sewage, as herein described in the Sanitary Use Regulations, shall be charged at a rate of twenty-four dollars and forty-five cents (\$24.45) per thousand cubic feet of actual sewage flow where metered or actual water consumption where unmetered.

Where any building or structure is used for purposes comprised of more than one classification, the service fee in such case shall be the total of the fees for each such classification.

Minimum Charge.

Notwithstanding any of the schedules contained herein to the contrary, the minimum annual charge for any property connected to the Borough sanitary sewer system shall be one hundred twelve dollars (\$112.00).

The rates or charges as set forth in "Schedule A" above shall take effect on May 1, 2012 and be billed on or after May 1, 2012 for all customers.
