- Ken Olchaskey, 108 No. Edward Street

He commented about the actions of Councilman Grillo at the last meeting. He further stated that the COAH issue is the biggest issue Sayreville is facing right now. Councilman Grillo responded that it was discussed at three or four Planning Board meetings which were mostly in closed session.

Mr. Olchaskey said the residents were not informed about this issue. He questioned who is exactly being sued in Sayreville.

Response by Mr. Sachs.

Mr. Olchaskey questioned if this was a result of building that has gone on where we have not have an affordable housing component. He also asked if there was affordable housing in Towne Lake.

Mr. Sachs responded that there isn't and we were certified for the first round of COAH and second round. We are now dealing with the period from 2005 to 2025. Mr. Olchaskey was very disgusted that builder's got away without having affordable housing in their projects.

- Jim Robinson, 11 Borelle Square

He thanked the Mayor and Council for having Mr. Sachs and Mr. Leoncavallo stay for this meeting. He stated it's very hard to get information on the affordable housing issue. He questioned the amount of affordable housing units. He would like to know the amount of affordable units and market rate units.

Mr. Sachs responded the total number of affordable units is 785 what that comprises is 434 actual buildable units, received credit of 154 units from our prior round of certification. Then we received a rental bonus of 197 units. Kaplan Site 1 – 26 units Kaplan Site 2 – 45 units Cross Ave./National Lead Site – 25 units Luxury Pointe Site – 171 units Chase Partner Site – 22 units River Road Redevelopment Area – 24 units Accessory apartments throughout the municipality – 10 units Properties that are controlled by the municipality – 111 units All of those totals 434 units.

Mr. Robinson requested a copy of this and it should be on the website. He then asked for the total of market rate units. Mr. Sachs responded Kaplan Site 1 – 173 units Kaplan Site 2 – 300 units Cross Ave./National Lead Site – 163 units Luxury Pointe Site – 2,000 settlement agreement prior to COAH litigation Chase Partner Site – 148 units River Road Redevelopment Area – 160 units

Mr. Robinson stated that the Township of Woodbridge is building 96 units with no cost to the taxpayers. They received grants and are working with a non-profit organization. He then questioned the member on the Planning Board that were not reappointed.

Council President Buchanan asked Mr. Sachs what the rule is on not appointing members because there were several times during the year that he reminded the Mayor to make those appointments and he chose not to.

Mr. Sachs responded that if their term expired they should not be sitting on that board. He then answered Mr. Robinson's question and stated that there was always a quorum at the Planning Board.

- Jorge Gonzales, Kimball Drive West

He mentioned from previous meetings that Councilman Grillo stated that 112 units were going on Housing Authority property. He asked for an elaboration.

Mr. Sachs responded that it's a combination of municipally controlled properties. Mr. Gonzales stated he's the chairman of the housing authority and has no clue what they are talking about.

Council President Buchanan stated that he thinks there's confusion between the redevelopment property and housing authority running it.

Mr. Gonzales stated that we came before the Mayor and Council two years ago putting 75-80 units of affordable housing and it was ignored. He also stated Mrs. Kilcommons deserves an apology.

- Barbara Kilcommons, 22 Schmitt Street

Questioned Councilman's Grillo title of employment.

Councilman Grillo responded that he's a city planner for a non-profit economic development group.

Mrs. Kilcommons stated she deserves an apology.

Councilman Grillo responded that she comes up here and insulted the integrity, honesty, dedication, and work ethic of this entire governing body. In his opinion she wasn't being intellectually honest.

Mrs. Kilcommons stated that the borough is lacking senior homes like Spinnaker Pointe, assisted living, veteran homes not for developers to build single family homes to make a lot of money.

Councilman Grillo responded that we are going to have a separate meeting about how we can incorporate those options on the sites we have identified.

Mrs. Kilcommons commented that we need ratables in this town. The town needs to plan better.

Commented on the amount of housing they want to put between North Ernston and Main Street and traffic in town.

- Mike D'Addio, 13 Zaleski Drive

Commented on some of the property that Mr. Sachs and Mr. Leoncavallo are talking about is SERA owned property. One of the sites by the senior center is set to be redeveloped and they can build just affordable housing on because there are no height requirements in a redevelopment zone. He believes redevelopment is the way to go.

- Judy McCrone, 312 Stevens Avenue

She stated that her and members of her community have been trying to improve the look and the quality of life their neighborhood. They requested to have a "Welcome to Morgan" sign coming over the Morgan Bridge. Two sponsors are willing to pay for the sign.

Mayor questioned if sign was on borough property.

Response from Tom Pollando in audience.

Mayor stated that if they want a neighborhood sign they'll look into how much one does cost and stick it on public property.
