Mr. Sachs responded that he has to appear in court on June 1, 2017 and will let the judge know that the ordinances were introduced and the public hearing is scheduled for June 26, 2017.

Council President Buchanan questioned if there is any way of working more on this plan.

Mr. Sachs responded that it's a fluid document and if there's questions about possible amendments it needs to be brought to his attention as well as Planning.

Borough Attorney DuPont questioned if they would need to hire another planner.

Councilman Grillo stated they need a point of clarification from the planner regarding two concepts they agreed on in closed session. One was for a potential multi level mixed use development & potential rezoning on Route 35. The other was for a potential adaptive reuse plan.

Mr. Leoncavallo stated they would need to amend the Master Plan which the housing plan element is part of. The options that can be done are either amend the Master Plan or do a reexamination report.

Council President Buchanan questioned how they got into this position. He stated it's appalling that all these ordinances need to be changed and the public should know why.

Mr. Sachs responded that it's several years of litigation at this point. He stated that where we are now is that the settlement agreement was approved by the council last July. Between last July and August we are required to come up with enabling ordinances to facilitate the affordable housing settlement.

Council President Buchanan questioned why we have to meet these affordable housing requirements and why wasn't it done in the past.

Mr. Sachs responded that it was done in the past to some degree but what happened was the Borough was certified for the 2nd and 3rd round COAH. COAH was disbanded a couple years ago. A case that went before the NJ Supreme Court mandated that the judges in each County would be responsible for administering the affordable housing programs in each municipality. Each municipality filed declaratory actions that they were COAH certified. That's where we are today.

Council President Buchanan stated that being the Borough has to build affordable housing we also have to build market value homes.

Councilwoman Kilpatrick questioned why there were no affordable housing units in Camelot at Towne Lake.

Mr. Sachs responded the one that did have an affordable housing requirement were Chase Partners.

Councilwoman Kilpatrick stated awhile back she requested Veteran housing to comply with some of our COAH obligations. She stated she is okay with introducing but moving forward she's not okay with this plan.

Councilman Grillo stated he would like to empower whether it's Councilman Lembo or the planner to bring to the Planning Board the request for a zoning amendment analysis for Route 35 and potential adaptive reuse plan.

Councilman Melendez asked for an explanation of what happened since last July.

Mr. Sachs responded that after the lawsuit was filed, a special master was appointed, with her assistance she facilitated a settlement which was approved by the court and the council last summer. The agreement provided for how many units. There were developers who intervened in the settlement.

Councilman Melendez questioned if there was a plan along with the agreement.

Mr. Sachs responded that there were concept plans.

Councilwoman Novak stated that's the only thing they agreed to. They were never told that they would have to rezone any property and would be increasing density. The only problem is the fact we will have to allow at least 2,000 market units.
