The well-being and safety of Sayreville's residents is my top priority, especially now as we are facing an unprecedented global health pandemic. On May 17th, as I was walking through Kennedy Park, I noticed that about twenty people were using the skate park in direct violation of the governor's orders regarding self-distancing. I spoke to several middle-school children who were standing next to a sign stating that the park was closed and reminded them that they could not use the skate park. The children apologized and promptly left.

Unfortunately, the adults in the crowd were not nearly as respectful or cooperative. One, a grown man, continued to use his bike in the bowl of the skate park, despite knowing full well that the park was closed. Once the children left, he became menacing and aggressive and only left as the police arrived.

It is a sad day when adults behave less responsibly than middle-school children. It is even sadder when selfish behavior jeopardizes the life and health of vulnerable members of our community. I will never apologize for working diligently to keep our residents safe and call upon all our neighbors to treat each other with kindness and respect during this most difficult time. Today, tomorrow, together.
