Mayor O'Brien opened the Council Meeting at 7:00 PM followed by a short prayer and salute to the flag.

#### PROCLAMATION & PRESENTATIONS

Presentation given by Dan Aloia from Unified Technology Partners for the Sayreville Infrastructure Security at the Sayreville Water Treatment Plant and Duhernal Site – Review and Recommendations

He reported on the Water Treatment Plant and Maintenance Facility and that the equipment that existed was dated or non-existent. Stated that the facility itself had a natural boundary because it extends far back. However suggested some jersey barriers or large boulders be placed to stop large trucks from entering. He said that the report also covered the gates and tanks at this location. He also spoke about the concerns at Duhernal and the many points of entry which is covered in the report. He then asked for questions from the governing body.

Co. Melendez said he is the IT Liaison. He said that after reviewing the report, half is physical and the other is technology and asked if the security improvements could be done in phases, some now and some at a later date. Mr. Aloia said that the fencing was a concern especially because of the ballfield on the east side and the existing fence is deteriorated and some missing and the opposite side has the same concerns because of businesses and the horse stable. The North side has such thick brush is stands as a natural barrier and can be as subsequent phase. The street level side has pretty good fencing. He indicated that the technical layer is more of a concern. So if the project were to be split up he would suggest to do partial on the physical and more on the technology side. He went on to talk about cameras and how they should be populated on the screen.

Co. Grillo said that the fencing would be denying public access and is that what he is understanding. Mr. Aloia said yes in the beginning but the maintenance is the issue years down the road. This needs to be kept up with. Co. Grillo expressed his concern about cutting off half of the access to the Nature Preserve with fencing and felt that fencing was not that secure as cameras would be. Cameras could be monitored or triggered by certain types of movement. Felt this would be a much wiser investment and would not preclude the public from property they can use today. Mr. Aloia addressed the issue being a very heavily wooded area and then would need a lot of cameras to be as effective as a fence line. Mr. Aloia explained how a fence line could preserve the natural preserve forcing people to use the proper entrances. Further discussions took place on the type of fencing and cameras.

Councilman Grillo and Co. Lembo expressed their concerns about the expense of the fencing and the actual need. The Mayor brought up the areas used by people, organizations, hunters, etc.

Mr. Frankel explained that there are DEP regulations that Sayreville needs to protect our potable water source there. That there are areas that need more than security cameras the areas would have to be secured. Mr. Frankel asked what measures we need to take to come into compliance and that these are rules and regulations that the DEP in imposing upon us and not limiting access to the public.

Mr. Aloia said the areas of concern was the plant and protecting the three lagoons.

Mayor called forward Stanley Drwal who as Councilman created the nature preserve.

Stanley Drwal, 121 Bissett Street.

Spoke about the fencing at the lagoons and explained how he got involved and the preservation area. He also gave his background in security. He felt the real concern was the water plant itself. He said that the security and protection of the lagoons is a waste of money. Co., Melendez said that there needs to be further clarifications as to what the use of the lagoons are and inform the DEP.

In closing Councilman Grillo said that he would like to have a Water Committee meeting on June 25<sup>th</sup> at 5:45 PM and have the Water & Sewer Director present to clarify these questions and DEP regulations.

#### OLD BUSINESS:

Mayor asked if there was any Old Business. Clerk reported there being none.

Mayor stated that he returned Resolution #2018-157.

A Resolution of the Borough of Sayreville, County of Middlesex, State of New Jersey. Authorizing the Mayor to execute the Settlement Agreement. He said that he is returning it as a Veto for the following reasons: He said that when the original order came through the financial onus was on the developers, now it is on the borough. He said that the biggest problem for him is that we had zero costs before and in a worst case scenario we could have upwards of \$19 million dollars. He said that the other thing that he has great difficulty in is that we are a creating low income cluster and before he come on the council he was the Chairman of the Housing Authority and we have other low income clusters in Sayreville and what was happening was to some degree was becoming generational. Where the original purpose was to help people get back on their feet and this seemed like this was encouraging people not to leave and move on and these are the two primary reasons that he is returning as a Veto. The Council can override the veto. But personally he said that he could not sign it.

Councilman Buchanan asked if this was a resolution or an ordinance. Clerk responded resolution. He then asked if a resolution could be vetoed by the Mayor. The Borough Attorney further stated that the council would have the right to authorize the Business Admin. to execute the Agreements if the Mayor does not sign. He said that it would be a motion authorizing the Borough Administrator to execute the Agreements with National Lead, Fair Share Housing and K-Land Corp. Council President asked if he was vetoing all the corresponding resolutions or just #157. Mayor stated that if he vetoed the Fair Share Housing one it would preclude the other two. He said that they are all part of the same.

The Borough Attorney said that a Motion be made authorizing the Business Administrator to execute the agreements necessary for Fair Share Housing, National Lead and K-Land Corporation. Councilman Grillo asked why the BA and not the Council President. Mr. DuPont said that any and all agreements can be executed by the Borough Administrator if authorized by the Mayor and Council. Council President Kilpatrick said that she listened to the Mayor's reasons for veto or refusal to sign. But she said that she believes that he is particularly referencing the River Road Redevelopment Site when he spoke about the cost that would be incurred

and that we would be creating a pocket of housing for individuals and what she liked about that site and what SERA signed on for was the fact that this would be a Veteran Preference Housing complex. The fact that the Mayor is vetoing all of these resolutions – the Fair Share Agreement he would be basically vetoing the ability for veterans to have access to affordable housing. Council President Kilpatrick then made a Motion rescinding resolutions 2018-157, 2018-158 and 2018-159 and creating a Resolution authorizing the Business Administrator or the Council President the ability to execute the Resolutions and Agreements. Motion was seconded by Councilman Buchanan.

Comments made by Councilwoman Novak regarding the River Road Redevelopment Site and that SERA stepped up to the plate and Co. Kilpatrick worked very hard on this matter and it would be Veterans Preference housing and by having this we were able to cut back the required number of housing in other areas.

Council President Kilpatrick said that with having the veteran preference site and with Surenian and his team we were able to get a 30% reduction in overall market rate units and still able to achieve the affordable housing units that we were required to. After bringing in Susan Gruel as our Planner, she found many affordable housing units that were currently here and not being credited and now are and reduce the overall number as required and work out an agreement with the developers and have an opportunity for one space to be obtained as "open space". She also spoke about the reduction of units in National Lead and Bed Room reduction and the reduction in the number of units at K-Land. Density was reduced.

The Borough Attorney said that he would have the Resolution(s) prepared for the next meeting.

Mayor O'Brien called for the next matter.

**WHEREAS,** Ikon at Route 35 Corporation is the holder of Plenary Retail Consumption License #1219-33-001-013 in the Borough of Sayreville; and

**WHEREAS,** the licensee did file a verified petition requesting authorization for the Borough of Sayreville to consider its renewal application for the 2018-2019 license term; and

**WHEREAS,** on December 7, 2017, David P. Rible, Director of the State Division of Alcoholic Beverage Control, did make a Special Ruling to permit the filing of a renewal application of an inactive license, pursuant to N.J.S.A. 33:1-12.39, Agency Docket No. 06-17-699 for a *two-year period*, covering the *2017/2018 and 2018/2019 license terms*; and

**WHEREAS,** the said Special Ruling of the Director does authorize the Mayor and Borough Council to consider the application for renewal of the subject license for the 2018/2019 license term and to grant or deny said application in the reasonable exercise of its discretion;

**WHEREAS,** said applicant has complied with the necessary requirements including payment of fees, etc.

**NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED** that the Mayor and Borough Council do hereby grant the renewal of Plenary Retail Consumption License No. 1219-33-001-013 to the licensee for the 2018/2019 license term, pursuant to special conditions as contained in the Special Ruling issued by the Director of the State Division of Alcoholic Beverage Control issued on December 7, 2017, subject to the following conditions that remain as part of the license:

- 1. Licensee shall continue to implement and provide valet parking for its patrons on all nights of operation. The Chief of Police may grant a waiver, on occasion, of the requirement that valet parking be provided if the Licensee demonstrates, to the reasonable satisfaction of the Chief of Police, that Licensee's level of occupancy on such specific occasion is anticipated to be significantly less than the legal occupancy so as to satisfy the Chief that valet parking will not be necessary on such specific occasion. The granting of any such waiver on one occasion shall not entitle Licensee to such a waiver on any other occasion.
- 2. The above-described valet parking requirement shall remain in effect unless and until a recommendation for other appropriate traffic control procedures, developed by a licensed traffic or civil engineer or consultant at Licensee's expense, is received and approved by the Mayor and Council as a substitute measure.
- 3. Licensee shall institute a policy and instruct its parking lot attendants and employees to abide by a policy that requires that, when the parking facilities used by the Licensed Premises are at full capacity, any additional cars seeking to enter the parking lots shall be "waved off" by parking lot attendants in order to insure that traffic jams do not occur but that such traffic continues to move through and out of the area of the Licensed Premises when there are no legal spaces available in the Licensed Premises parking lots to accommodate additional cars.
- 4. Licensee shall strictly enforce a policy that patrons who have been admitted to enter the Licensed Premises who subsequently exit the Licensed Premises

will not be permitted to re-enter the Licensed Premises on the same day/evening. This measure is intended to address the Mayor and Council's previous finding that drug activity was noted on the Licensed Premises and in recognition of the fact that a practice of allowing patrons to exit and then reenter the Licensed Premises facilitates drug activities by providing an opportunity for such persons to retrieve contraband from their vehicles for use and/or distribution inside and adjacent to the Licensed Premises. Additionally, this measure is intended to alleviate the problem of patrons loitering in and around the parking lot during Licensee's operating hours and engaging in illegal, disorderly or nuisance causing behaviors.

- 5. Licensee's security staff shall be required to obtain photo identification cards, prepared by the Sayreville Police Department, that must be kept on their persons at all times while employed at or located on Licensee's property. This measure is intended to alleviate difficulties encountered by police investigating complaints on the premises, in which members of the security staff are identified as either potential witnesses or suspects and is also designed in response to the findings of a previous ABC investigation in which it was discovered that some of the employees found on-site during the investigation were not properly entered in Licensee's employee records.
- 6. Licensee shall provide proper trash receptacles in the parking lot and shall cause Licensee's parking lots and outside premises, as well as all residential areas within a five hundred (500) foot radius of the Licensed Premises, to be cleaned of all litter, trash and other discarded items. Such cleaning shall be accomplished by ten o'clock in the morning (10:00 a.m.) each day following the hours of operation of the Licensed Premises such that the above-described areas shall be free from all such litter, trash and other discarded items as may be generated by and/or associated with Licensee's operation. To the extent that residents within such five hundred (500) foot radius consent to permit access to private property for the purposes of such cleaning on private property, Licensee shall cause such private property to be cleaned of all litter, trash and other discarded items, at Licensee's sole cost. This measure is designed to alleviate any problem associated with the accumulation of empty beverage containers, cans, bottles and other debris that results from the operation of the Licensed Premises.
- 7. Licensee shall install "zero tolerance" signs inside the Licensed Premises, at or adjacent to the entry to the premises, containing language indicating that patrons will be prosecuted to the fullest extent of the law for any possession, sale or distribution of any drug, controlled substance or drug paraphernalia. This measure is designed to discourage drug activity occurring at or on the Licensed Premises.
- 8. Licensee shall install soundproofing equipment and/or take any other necessary steps to limit the escape of sound and vibration from the Licensed Premises, sufficient to ensure that no audible sound is transmitted beyond the property line of the Licensed Premises. This measure is designed to alleviate concerns regarding noise levels as recounted from complaints received by members of the Council pertaining to the Licensed Premises.
- 9. Licensee shall cease all sales of alcohol at 1:30 a.m. and shall cease the playing of all music at 1:45 a.m. This measure is designed to facilitate the prompt and orderly exiting of patrons at or before the time of closing and to prevent large groups of patrons from exiting the Licensed Premises at the same time, resulting in loitering around the Licensed Premises and in the street, blocking traffic and inhibiting the dispersal of other patrons from the Licensed Premises and from the area.
- 10. Licensee shall institute a policy that on nights where patrons aged eighteen (18) through twenty (20) may be admitted to the premises along with patrons aged twenty-one (21) and over, such patrons over the age of twenty-one (21) shall be required to wear secure wristbands of a color differentiated from any wristbands required to be worn by patrons under the age of twenty-one (21). All such wristbands shall be incapable of being reattached once removed, in order to prevent violations of laws prohibiting sales of alcohol to persons under twenty-one (21). This measure is designed

to prevent violations of drinking age laws, as noted by the Council in previous findings of fact related to a prior disciplinary action.

- 11. Licensee shall securely stow all alcoholic beverages and shall not serve any alcohol whatsoever on those occasions that Licensee provides access to teenagers under the legal drinking age at events commonly referred to as "Teen Nights". During such events, all alcoholic beverages shall be removed from the bar areas and secured. This measure is designed to prevent violations of drinking age laws as noted by the Council in previous findings related to a prior disciplinary action. 2018-173
- 12. Licensee shall require all security staff, except for undercover security staff employed by Licensee, to wear clothing or uniforms which are highly visible and well marked on the front and rear. This shall include orange shirts with black block letters stating "SECURITY". This measure is designed to ensure that security staffers constitute a visible, identifiable and adequate security presence to discourage unlawful, disorderly, or hazardous activities within the Licensed Premises and in the parking lot to further assist police in identifying security personnel when patrolling or responding to complaints or calls.
- 13. Licensee shall institute a policy of providing security staff in a ratio of one (1) security employee for each fifty (50) patrons, and that such security personnel be stationed in the parking lot area of the premises at all times during the hours of operation to control and supervise the parking lot area, not only with regard to parking, but with regard to the conduct and behavior of the patrons while on the Licensed Premises. Parking attendants and valet parking staff shall not count as "security staff" in calculating the proper ratio of security staff to patrons. The ratio of one (1) security employee for every fifty (50) patrons is only for those security personnel who are being identified and/or are in uniform. Any undercover personnel that Licensee wishes to employ are in addition to the one per fifty patron security ratio. This measure is designed to ensure that the security staff employed by Licensee is sufficient to handle the numbers of patrons in attendance on a given night so as to constitute a visible, identifiable and adequate security presence, to discourage unlawful, disorderly, or hazardous activities within the Licensed Premises and in the parking lot.
- 14. On promotional evenings, when a large crowd is expected, Licensee will coordinate with the police.
- 15. Licensee shall strictly enforce a policy to bar admittance to any patron who is not wearing a non-removable wristband, that has been provided to such patron by Licensee's valet parking attendant or parking supervisor, as evidence that the vehicle in which such patron arrived at the Licensed Premises has been parked in Licensee's parking lot. The only exception to this policy shall be for those patrons who demonstrate to Licensee before admittance that they hold a valid New Jersey motor vehicle license indicating that they reside within five hundred (500) feet of the Licensed Premises and have not arrived at the Licensed Premises in a motor vehicle. This condition is intended to restrict admittance to the Licensed Premises to only those patrons whose vehicles, as a driver or occupant thereof, are lawfully parked in Licensee's parking lot, in order to address issues raised by an Objector and her witnesses regarding illegal parking, property trespass, loitering and related nuisances.
- 16. Licensee shall institute a policy requiring its security staff to immediately report to the Sayreville Police Department any violations of Title 39 observed by such staff in and around the Licensed Premises, and to provide the Borough clerk, on a monthly basis, with a list of all such reports made by Licensee's security staff to police within the prior month.
- 17. On a weekly basis, Licensee will deliver in person, mail, or fax a copy of the E-141-A list, commonly known as the employee list, to the Police Department. DJs, dancers, and other entertainers are to be included as employees, as per ABC rules.

18. Licensee shall provide a list of entertainers who are booked prior to the scheduled date. The information shall be delivered to the Sayreville Police Department at the time a contract is executed and signed and the information shall be delivered to the Sayreville Police Department as to the name of the outside entertainer employees.

This measure is designed to facilitate the prompt and orderly exiting of patrons at or before the time of closing and to prevent large groups of patrons from exiting the licenses premises at the same time, resulting in loitering around the licensed premises and in the street blocking traffic and inhibiting the dispersal of other patrons from the licensed premises and from the area.

h. The licensee shall install a policy that on nights when patrons ages eighteen years of age (18) through twenty years of age (20) may be admitted to the premises along with patrons aged twenty-one years (21) and over, such patrons over the age of twenty-one years (21) shall be required to wear secure wrist bands of a color differentiated from wrist bands required to be worn by patrons under the age of twenty-one years (21). All such wristbands shall be incapable of being reattached once removed in order to prevent violations of law prohibiting sales of alcohol to persons under twenty-one years of age (21).

- i. The licensee shall securely stow all alcoholic beverages and shall not serve any alcohol whatsoever on those occasions that the licensee provides access to teenagers under the legal drinking age at events commonly referred to as "teen nights." #### CONDITIONS ON P.R.C.L. #1219-33-058-007 PURE EVENT CENTER, INC.

- 1. Licensee shall strictly enforce a policy that patrons who have been admitted to enter the Licensed Premises who subsequently exit the Licensed Premises will not be permitted to re-enter the Licensed Premises on the same day/evening. This measure is intended to address the Mayor and Council's previous finding that drug activity was noted on the Licensed Premises and in recognition of the fact that a practice of allowing patrons to exit and then re-enter the Licensed Premises facilitates drug activities by providing an opportunity for such persons to retrieve contraband from their vehicles for use and/or distribution inside and adjacent to the Licensed Premises. Additionally, this measure is intended to alleviate the problem of patrons loitering in and around the parking lot during Licensee's operating hours and engaging in illegal, disorderly or nuisance causing behaviors.
- 2. Licensee's security staff shall be required to obtain photo identification cards, prepared by the Sayreville Police Department, that must be kept on their persons at all times while employed at or located on Licensee's property. This measure is intended to alleviate difficulties encountered by police investigation complaints on the premises, in which members of the security staff are identified as either potential witnesses or suspects and is also designed in response to the findings of a previous ABC investigation in which it was discovered that some of the employees found on-site during the investigation were not properly entered in Licensee's employee records.
- 3. Licensee shall provide proper trash receptacles in the parking lot and shall cause Licensee's parking lots and other outside premises, as well as all residential areas within a five hundred (500) foot radius of the Licensed Premises, to be cleaned of all litter, trash and other discarded items. Such cleaning shall be accomplished by ten o'clock in the morning (10:00 a.m.) each day following the hours of operation of the Licensed Premises such that the above-described areas shall be free from all such litter, trash and other discarded items as my be generated by and/or associated with Licensee's operation. To the extent that residents within such five hundred (500) foot radius consent to permit access to private property for the purposes of such cleaning on private property, Licensee shall cause such private property to be cleaned of all litter, trash and other discarded items, at Licensee's sole cost. This measure is designed to alleviate any problem associated with the accumulation of empty beverage containers, cans, bottles and other debris that results from the operation of the Licensed Premises. .
- 4. Licensee shall construct and maintain an 8' high solid fence at the rear property line mandated by the Planning Board Resolution dated March 2, 2016, before conducting any public event.
- 5. Licensee shall install "zero tolerance" signs inside the Licensed Premises, at or adjacent to the entry to the premises, containing language indicating that patrons will be prosecuted to the fullest extent of the law for any possession, sale or distribution of any drug, controlled substance or drug paraphernalia. This measure is designed to discourage drug activity occurring at or on the Licensed Premises.
- 6. Licensee shall install soundproofing equipment and/or take any other necessary steps to limit the escape of sound and vibration from the Licensed Premises, sufficient to ensure that no audible sounds is transmitted beyond the property line of the Licensed Premises. This measure is designed to alleviate concerns regarding noise levels as recounted from complaint received by members of the Council pertaining to the Licensed Premises.
- 7. Licensee shall keep all doors at the rear of the building closed.

- 8. Licensee shall cease all sales of alcohol at 1:30 a.m. and shall cease the playing of all music at 1:45 a.m. This measure is designated to facilitate the prompt and orderly exiting of patrons at or before the time of closing and to prevent large groups of patrons from exiting the Licensed Premises at the same time, resulting in loitering around the Licensed Premises and in the street, blocking traffic and inhibiting the dispersal of other patrons from the Licensed Premises and from the area.
- 9. Licensee shall require security staff, except for undercover security staff employed by Licensee, to wear clothing or uniforms which are highly visible and well-marked on the front and rear. This shall include orange shirts with black block letters stating "SECURITY". This measure is designed to ensure that security staffers constitute a visible, identifiable and adequate security presence to discourage unlawful, disorderly, or hazardous activities within the Licensed Premises and in the parking lot to further assist police in identifying security personnel when patrolling or responding to complaints or calls.
- 10. Licensee shall institute a policy of providing security staff in a ratio of one (1) security employee for each fifty (50) patrons, and that such security personnel be stationed in the parking lot area of the premises at all times during the hours of operation to control and supervise the parking lot area, not only with regard to parking, but with regard to the conduct and behavior of the patrons while on the Licensed Premises. Licensee shall post a security guard in the rear parking lot during its hours of operation. Parking attendants and valet parking staff shall not count as "security staff" in calculating the proper ratio of security staff to patrons. The ratio of one (1) security employee for every fifty (50) patrons is only for those security personnel who are being identified and/or are in uniform. Any undercover personnel that Licensee wishes to employ are in addition to the one per fifty patron security ratio. This measure is designed to ensure that the security staff employed by Licensee is sufficient to handle the numbers of patrons in attendance on a given night so as to constitute a visible, identifiable and adequate security presence, to discourage unlawful, disorderly or hazardous activities within the Licensed Premises and in the parking lot.
- 11. Licensee shall strictly enforce a policy to bar admittance to any patron who is not wearing a non-removable wristband, that has been provided to such patron by Licensee's valet parking attendant or parking supervisor, as evidence that the vehicle in which such patron arrived at the Licensed Premises has been parked in Licensee's parking lot. The only exception to this policy shall be for those patrons who demonstrate to Licensee before admittance that they hold a valid New Jersey motor vehicle license indicating that they reside within five hundred (500) feet of the Licensed Premises and have not arrived at the Licensed Premises in a motor vehicle. This condition is intended to restrict admittance to the Licensed Premises to only those patrons whose vehicles, as a driver or occupant thereof, are lawfully parked in Licensee's parking lot, in order to address issues raised by at the Planning Board regarding illegal parking, property trespass, loitering, and related nuisances.
- 12. Licensee shall institute a policy requiring its security staff to immediately report to the Sayreville Police Department any violations of Title 39 observed by such staff in and around the Licensed Premises, and to provide the Borough Clerk, on a monthly basis, with a list of all such reports made by the Licensee's security staff to police within the prior month.
- 13. On a weekly basis, Licensee shall deliver in person, mail, or fax a copy of the E-141-A list, commonly known as the employee list, to the Police Department. DJs, dancers and other entertainers are to be included as employees as per ABC rules.
- 14. Licensee shall provide a list of entertainers who are booked prior to the scheduled date. The information shall be delivered to the Sayreville Police Department at the time a contract is executed and signed and the information shall be delivered to the Sayreville Police Department as to the name of the outside entertainer employees.

- 15. Teen nights are prohibited.
- 16. All patrons will have their vehicles valet parked, and upon presenting proper ID, will receive a wristband. Once a person exits the premises, they cannot re-enter.
- 17. Occupancy shall be limited to six hundred (600) persons.
- 18. During the six months following June 30, 2016, no more than five (5) public events shall be permitted on the premises. Thereafter, no public events may be conducted without Planning Board Approval and subsequent amendment of this Condition.
- 19. Notice of all public events shall be provided to the Sayreville Police Department at least seventy two (72) hours in advance of any public event scheduled on the premises. Licensee shall participate in community meetings if requested by the Police Department.
- 20. During public events, the licensee shall submit to random noise level readings by the Sayreville Police Department.
- 21. Licensee shall provide independent noise level readings for every public event for review by the Police Department within 72 hours after the event. Noise levels must meet the State standards contained in N.J.A.C. 7:29-1, *et seq.*

At this time Mayor O'Brien opened the meeting to the Public for questions or comments on any and all matters.

Those appearing were:

Brought up once again about representatives from the various boards attending the council meetings when there were important topics listed that would apply to their particular board or committee.

The Borough Attorney responded that at the upcoming Planning Board meeting Mr. Surenian and/or Mr. Edwards our COAH attorneys would be in attendance as well as Susan Gruel our Planner to answer any questions anyone may have.

Thanked the council for getting the bridges completed in Kennedy Park, but had one concern that the steel beams on the bridges were all rusted. There were no finish to them.

The engineer stated that is just the way they are designed, they are designed just as they are on the highways. No Maintenance.

#### - Charlie Lukie, 324 Oak St.

He commented that at the busiest intersection in Melrose is at Laurel & Ridgeway. There is telephone pole that is 20% off center with major wires. Pole is dry rotted and splintering. Concerned it would come down. Asked if the engineer could inspect it.

#### - Janice Benedetto, 1 Thomas Avenue

She stated that the residents of Melrose were sold out. That the settlement is all in favor of National Lead. She questioned the number and use of the credits and what the are losing in the 22 acres of natural woodlands. She felt it was poorly negotiated and in the contractors favor. Concerned about the condition of Cross Avenue during construction and emergency exits. She went on to comment about the Master Plan from 1998 and how it read. She questioned when she should have been notified back in 1998 of a change in the Master Plan and in 2006. Response given by Council President Kilpatrick.

She commented on the difference in the Ordinances from the May 29<sup>th</sup> meeting to tonight.

The Borough Attorney responded that he would be willing to sit down and go over with her. The Clerk said that by law she is not required to put out ordinances upon introduction. The ordinances are introduced by title only. She is required to make copies available prior to and at the public hearing and that they be posted. Mr. DuPont further explained that these ordinances are not up for adoption tonight. They are scheduled for public hearing and adoption on June 25<sup>th</sup>.

She asked if there was a final settlement agreement. Mr. DuPont said that he would check with Mr. Edwards tomorrow. He also reminded her that she could also address these questions at the Planning Board meeting on June 13<sup>th</sup>.

She went on to question the Reforestation Ordinance and how it applied to the developers.

The Business Administrator explained that the developers were in court an intervenors and as intervenors they have rights received from the court. He said

that she is saying that they do not want the land developed and everyone from the council feels the same way, but the problem exists that – whether is did it now or on the Settlement Agreement, the Compliance Hearing on June 28th, the Judge would tell us to do it and we would have to comply. He suggested that she attend the compliance hearing on June 28th. He said that the negotiated and made the best situation possible. Council President Kilpatrick said that every stone and every opportunity, every option with this negotiations was brought to National Lead. Councilman Lembo stated that we had no leverage in this. The court ruled and we tried to get the numbers down anyway we could. Council President Kilpatrick said that the Planning Board could put some requirements upon the developers when they come before the board.

- John Piskorski, Hilltop Avenue

Commented about Optimum TV. Prices are outrageous, programs are constantly repeated.

Mr. Frankel responded that there was a representative from Optimum at past meetings and that we are in the midst of negotiating the renewal of the franchise agreement, pricing, service, etc. He said that the only other choice the residents have is satellite source TV. He also spoke about the limited access to Fios here in Sayreville.

Mr. Piskorski then asked what is being done with the speeding on Hilltop. Mr. Frankel said that we notified the Chief and will ask him to send patrols out again.

He then asked about the Main Street By-Pass. The engineer said that we are still waiting on the Army Corp of Engineers. They still have to issue a permit.

- Ken Olchaskey, 108 North Edward Street Questioned the status of the MCUA meeting.

Mr. Frankel reported that it will take place on June  $26^{\text{th}}$  in the Council Chambers.

Mr. Olchaskey addressed the cable TV issues. He said that we should have other Cable TV representatives attend meetings. He said that the cable companies are regulated by the Board of Public Utilities. He said the reps should come here and take accountability. He then spoke about how Judges are nominated in New Jersey and who is accountable for the members of the BPU and Cablevision.

Mr. Olchaskey went on to talk about the developers and those that come in with no affordable housing and who was responsible for that happening. He also went on to say that the River Road Redevelopment is not for "low income" it is for "affordable housing" which is a much different issue that low income or section 8 housing.

Council President Kilpatrick responded that this type of affordable housing is broken up into tiers, so there are variations of affordable housing based upon income and those tiers are broken down according to law. This is for our young people and young families, single parents, etc.

- Charlie Lukie, Melrose

Questioned the time of the MCUA meeting.

Questioned effluent out of the Cross Avenue Housing. Discussion on it being the Developers responsibility. The engineer explained that it is part of the planning board application process.

No further questions or comments.
