Combined Meeting of the Mayor and Borough Council held on Monday, July 23, 2012, in the Borough Hall, 167 Main Street, Sayreville, was called to order by Mayor Kennedy O'Brien at 6:32 P.M. followed by a short prayer and salute to the flag.

Councilwoman Eicher moved the following minutes of the Mayor and Council be approved subject to correction if necessary:

Motion was seconded by Councilman Perrette.

PRESENTATION

- O'Neill Properties & Joseph Ambrosio, SERA Director
- Brian O'Neill, Jr., O'Neill Properties, 305 Titan Street, Philadelphia, PA

Addressed the Mayor and Governing Body regarding concerns made in a newspaper article regarding certain dredge soils from Middletown Twp. He started by giving a brief overall history of the site from an environmental standpoint and the process for accepting soil onto the site. He said that as part of the remediation process on the NL Site, they have to excavate hundreds of thousands of yards of contaminated material and so far they have excavated 250,000 cu. yds. of material pulled from the site so far. After the area is excavated the area will then need to be back filled with material that meets the site criteria. He explained that the site criteria is a document that was created by the Dept. of Environmental Protection of the State of New Jersey, which says what contaminates exist there now and what would have to be removed and what it can be replaced with and what those parameters are. He said that the criteria have been vetted through their Engineers, Rue Associates and SERA's Engineers as well as the DEP. He then reviewed the application process and types of questions on that application, if there is a fill provider. They would need to provide a data package and those test results. He said that this process has happened for each teaspoon of soil brought onto the site. He said that to date they have imported approximately 300,000 yards of material to be used as back fill and none of it has come from the Middletown site. He also explained that Middletown Twp. would have to go through the same process. The application was first reviewed by their engineers and sent it over to CME Associates which essentially said that they

need more data and right now it does not fit within the requirements and that was then forwarded to T&M Associates who is the engineers for Middletown Twp. So as it stands today that material is not approved for use at the National Lead Site.

Joseph Ambrosio, Executive Director of SERA

He concurred with Brian O'Neill, that it is a several step process in which one step is that SERA would have to approve the material that comes in and those that are on site are vetted, approved, checked when they come on site, deposited in segregated sections and checked again. So there are steps to make sure they are in compliance with State requirements. He said specifically as to Middletown, SERA has not approved any dredged materials from Middletown. He said that there was an application made and that application was reviewed by our engineer, CME Associates and found some concerns about certain levels that were indicated in the testing that had been produced and requested further documentation from their engineer and that information has not been forthcoming and that was several months ago. So, SERA has not approved dredged materials from Middletown onto the site.

He said that Brian O'Neill correctly reflected the process, which is a very detailed step by step process. Extreme caution is being taken to remove the materials to make sure that it is transported safely and that process has just begun by means of covered trucks and rail lines, depending on the materials which again also have to follow the appropriate guidelines.

Mayor asked if there were any questions from the governing body.

Councilman Henry questioned if he was correct in that the testing that was done on the Middletown material was not to their satisfaction or levels in order to accept those materials.

Mr. O'Neill responded that what he could recall is that their engineers required further testing be done that theirs was inadequate at that time.

Mr. Ambrosio concurred with the response.

Councilman Bella asked if they anticipate ever getting that data from the Middletown engineers.

Mr. O'Neill responded that he did think that they would.

Councilman Bella then questioned that when they receive that data and if it is within the limits set by the DEP, would they accept that material.

Mr. O'Neill responded that it has been their policy to date that they accept any that comes in and meets the criteria.

Councilman Bella then questioned that when it meets the criteria set by DEP, there are no hazards in accepting the material and why use this material over clean fill.

Mr. O'Neill said that they would and that there is a distinction between this type of fill and clean fill like top soil.

Mr. O'Neill said that when the soil come in it is deemed clean and that top soil could not be used for this it is for landscaping and meets a certain organic content.

Councilman Henry questioned if any level of arsenic would acceptable.

Mr. O'Neill said that there a variety of certain chemicals that would be acceptable in any fill situation. DEP has standards, such as the dirt in your own back yard. So to say that any fill has zero readings of any chemicals just is not true.

Mayor asked if anyone from the public has questions on this topic they could meet with Mr. O'Neill and Mr. Ambrosio in room 310 and have a dialog but asked that they limit it to 3 -4 questions. The Mayor also said that he asked Mr. Ambrosio as the Director of SERA and Mr. O'Neill as the primary Developer of NL if they would update the governing body on a monthly basis. Mr. Ambrosio informed the Mayor that at their SERA meetings, there are barely any people from the public who attend.

Mr. Ambrosio explained that SERA frequently has meetings and that there are posted on the borough web and bulletin board. People could contact himself or Mr. Travisano the Chairman if anyone has any questions.

Mr Bella addressed the issue about the amount of time SERA is in closed session and asked Mr. Ambrosio if he could guess on a percentage of SERA meetings may be in upcoming closed sessions.

Mr. Ambrosio said that would be difficult to assess, but he explained that anyone familiar with this project understands that there has been a lot of litigation, contract negotiations and topic like these are required by law to cover and they be covered in executive session until resolved. He also reiterated that anyone wanting to know can attend their meetings, call himself or the chairman, Mr. Travisano and they would explain to the extent that they can. He also explained that the topic for closed session are listed on the agendas.

Mayor said that the meetings are also posted on the bulletin board, the web site and the public access television. At this time Mayor asked that anyone having any further questions of Mr. Ambrosio or Mr. O'Neill now meet with them in the conference room.

Mayor called for the next item of business.

Mayor asked the Business Admin. for an update.

Mr. Frankel said that at the Budget Meeting on Monday he was charged with the task to reduce the budget even further. He said that he met with department heads and then reviewed the budget with the Wayne Kronowski and Dan Balka and came up with a reduction of \$182,000.00. \$82,000.00 was in Operating Expenses and the rest was from the Capital Budget and because this budget is being reduced \$182,000.00 there needs to be a Resolution Amending the 2012 Approved Municipal Budget and if adopted tonight there will need to be a Public Hearing on August 13, 2012. This reduction would bring it down to 3.9 cents or \$56.04 to the average homeowner.

Mayor asked that he review the reductions.

Mr. Frankel said the reductions were in the following areas:

Construction - \$ 2,500.00 Sewer - \$10,000.00 Police - \$21,000.00 Office on Aging - \$ 1,000.00 Roads - \$10,500.00 Snow Removal - \$15,000.00 Municipal Clerk - \$ 7,500.00

Mayor then asked where the capital was and where it is now and what was cut.

Mr. Frankel said that originally we had \$200,000.00 and they are recommending the capital be reduced by \$100,000.00 and it is the council's option to decide which projects they would want to cut.

Mayor asked which projects were considered. Mr. Frankel responded that they were talking mostly about roads. And the Mayor asked how many roads would get paved out of this year's budget.

Mr. Balka thought that they would all be out. Councilman Perrette reminded the council that there were no roads paved last year.

Councilman Perrette asked such a general cut could be made from the budget not knowing where it is going to be reduced going forward? He said that 5% of the \$2,500,000.00, which would include William Street project and other roads. He said that you are reducing the budget by approximately .96 cents per month for the average homeowner. He said that it was financially irresponsible at this point. He said that the budget cut and how it is going to affect everyone in the town and not being able to do the roads in this budget will leave us without replacing any roads for another two years.

Councilman Bella stated that it was an important function of a councilman to participate in the budget process and as always tried to represent the residents in this process. He said he made a commitment to the Business Administrator that he could support a budget that was less than 4 cent increase. Councilman Bella said that if Councilman Perrette is so concerned about the reduction in services than instead of introducing this amendment at 3.9 cents why don't we then vote on the original budget that was previously presented.

Discussion between Councilman Bella & Councilman Perrette.

Councilwoman Eicher asked what budget the funds were coming from to cover the road repairs being made now.

Borough Engineer Cornell said that it was from 2010 funding. He explained improvements made in 2011 was from DOT Grant funds. He said the last budget were there was funding for road improvements was in 2010. He explained that at this point if the council were to authorize road repairs, they would be designed and probably bid and construction would probably start next year.

Before reading the Budget amendment into record, the Clerk asked the Mayor if she could have a straw poll vote on the Budget Amendment before reading the entire Resolution into Record.
