Section 1. The Borough Council of the Borough of Sayreville, New Jersey (the "Borough") has ascertained and hereby determines that it is necessary and desirable to raise money to finance the cost of the improvements described in Section 3 of this bond ordinance, which improvements are hereby authorized to be made or acquired by the Borough. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Borough in the principal amount not exceeding \$2,850,000 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

- Section 3. (a) The improvements hereby authorized and the purposes for the financing of which said obligations are the improvement of Norton Street, North Ernston Road, Vineyard Avenue, Chevalier Avenue (off Oak Street), Charles Street, Haag Street and Main Street Extension, together with all other work, materials and appurtenances necessary therefor or incidental thereto.
- (b) The estimated maximum amount of bonds or notes of the Borough to be issued for said purposes is \$2,850,000.
- (c) The estimated cost of said purposes is \$3,000,000, the excess thereof over the estimated maximum amount of bonds or notes to be issued therefor being the amount of said \$150,000 down payment for said purposes.

Section 4. The following additional matters are hereby determined, declared, recited and stated:

- (a) The said purposes described in Section 3 of this bond ordinance are not current expenses and are properties or improvements which the Borough may lawfully acquire or make as general improvements, and no part of the cost thereof has been or shall be specially benefited thereby.
- (b) The period of usefulness of said purposes within the limitations of the Local Bond Law, according to the reasonable lives thereof computed from the date of said bonds or notes authorized by this bond ordinance, is 10 years.
- (c) The supplemental debt statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk and a copy thereof has been electronically filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs in the State of New Jersey (the "Division"), and such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by \$2,850,000, and the said obligations authorized by this bond ordinance will be within all debt limitations prescribed by the Local Bond Law.
- (d) An aggregate amount not exceeding \$475,000 for interest on said obligations, costs of issuing said obligations, engineering costs and other items of expense listed in and permitted under Section 40A:2-20 of the Local Bond Law is included in the estimated cost of said improvements.

Section 5. Any funds from time to time received by the Borough as contributions-in-aid of financing the improvements or purposes described in Section 3 of this bond ordinance, including any grant, shall be used for financing said improvements or purposes by application thereof either to direct payment of the cost of said improvements or purposes, or to payment or reduction of the authorization of the obligations of the Borough authorized therefor by this bond ordinance. Any such funds so received may, and all such funds so received which are not required for direct payment of the cost of said improvements or purposes shall, be held and applied by the Borough as funds applicable only to the payment of obligations of the Borough authorized by this bond ordinance.

Section 6. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the said obligations authorized by this bond ordinance. Said obligations shall be direct and unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all of the taxable property within

the jurisdiction of the Borough for the payment of said obligations and interest thereon without

limitation as to rate or amount.

Section 7. The capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board of the Division showing all detail of the amended capital budget and capital program as approved by the Director of the Division, are

on file with the Borough Clerk and are available for public inspection.

Section 8. The Borough intends to issue bonds or notes to finance the cost of the improvements or purposes described in Section 3 of this bond ordinance. The Borough expects that the maximum principal amount of bonds or notes which will be issued to finance the cost of the improvements or purposes described in Section 3 of this bond ordinance is \$2,850,000. If the Borough incurs any such costs prior to the issuance of the bonds or notes, the Borough intends to reimburse itself for such expenditures with the proceeds of the bonds or notes.

**WHEREAS,** floods are the most common and most destructive natural disasters in the United States; and

**WHEREAS,** the National Flood Insurance Act authorizes a National Flood Insurance Program ("NFIP"); and

**WHEREAS,** the NFIP is a Federal program created by Congress to mitigate future flood losses nationwide and to provide access to affordable, federally backed flood insurance protection for property owners; and

**WHEREAS,** the NFIP is designed to provide an insurance alternative to disaster assistance to meet the escalating costs of repairing damage to buildings and their contents caused by floods; and

**WHEREAS,** New Jersey is fourth in the nation in the number of NFIP policies enforced and third in total value of claims paid; and

**WHEREAS,** five hundred and fifty-two communities in New Jersey participate as members of the NFIP which amounts to over 230,000 policies throughout the State of New Jersey; and

**WHEREAS,** the NFIP maintains a significant role in providing financial protection against flood events to New Jersey residents; and

WHEREAS, the NFIP is set to expire on September 30, 2017; and

**WHEREAS,** the expiration of this program could cause catastrophic loss of insurance coverage against flooding which is the number one cause of loss of property throughout the United States; and

**WHEREAS,** in the event the program were to expire, the consequences in the form of disruption of coverage and the potential financial burdens to residents throughout the State of New Jersey will be of great economic significance; and

Council President Buchanan announced that the COAH ordinances were not discussed tonight. He said that on August  $2^{nd}$  the Planning Board will be conducting a special meeting to discuss the Housing Plan and if they approve the plan it would come to the council on August 21, 2017.

# PUBLIC PORTION

At this time Council President Buchanan opened the meeting to the public for questions or comments on any and all items.

Those appearing were:

- Tom Bishada, Greenhill Avenue Complained about the public mics at the council meeting not being audible on SayTV. Questioned the procedure on putting a voter referendum on an election ballot. Explained by the Borough Attorney. Handed out and read an article regarding No Constitutional Right to Affordable Housing and asked that the council vote no on any of this affordable housing. Judge does not have any judicial right to force housing on Sayreville.

- Mike D'Addio, Chairman Sayreville Economic & Redevelopment Agency Stated that the Judge Tom was talking about is Judge Wolfsen, who is the assignment Judge who ruled on COAH. He said that although it is not in the Constitution, COAH was approved by State Legislature and Senate. It is a law. The Supreme Court ruled that we do have to do this. The borough settled for the number we have. Unfortunately, the Planning Board did not inform the council that they would have to build 7 marketable homes to 1 COAH to get to that number. So that was not approved nor in the ordinance. He said that we do have a good fight on our hands and intend to fight this. He said that at the last SERA meeting the SERA Commissioners as well as himself approved SERA to be interveners. So they will intervene and have their own housing plan. Urged everyone to attend the Aug. 2<sup>nd</sup> Planning Board meeting.

Councilman Grillo stated that it has been 42 days since Susan Gruel was appointed at a secondary planner and still have not received any correspondence from her regarding the plan they are paying her to produce. He asked if any other councilmembers had any discussions with her.

Councilwoman Kilpatrick responded that she had – with her, members of SERA and as many people as she could. She said that Susan Gruel was not taxed with creating the Housing Plan. She mentioned that Councilmen Lembo, Grillo and the Mayor did not want her to come in and look and review the plan prepared by the borough planner, Mr. Leoncavallo. She said that this was going ahead with zero input if they had not put the brakes on in February. She went on to explain what has happened for two years, in support by the Mayor. She said they were told about an overall number, not told about any specific sites. Never told that any of these areas would have to be rezoned or the density would have to be granted. She said that she has five sets of Housing Plans that have been changed in the last couple of months. Upset that she does not know which one would be presented on Aug. 2<sup>nd</sup>. We needed to hire Susan Gruel because our professionals did not do their due diligence in guiding the governing body with correct information and never brought in the Housing Authority and SERA to a meeting to discuss it. Further commented on the housing built over the past years. She said that if we build all of these types of homes contained in these plan we will not earn a type of credit in order to bring in other types of building for ratables and employment. Need so many points for a mixed use type of thing. And Sayreville will always be overcrowded, etc. She spoke about Veteran's preference housing and limited amount of different programs the state offers.

Councilman Grillo asked each councilmember if they spoke with Susan Gruel.

Mike Dupont reviewed what has been done since Susan Gruel was appointed. He discussed the Housing Plan produced by Mr. Leoncavallo and that it was revised on a few dates. He said that Ms. Gruel has come up with some alternatives, proposals and ideas. So there is no report because no final decisions have yet been made.

Councilman Grillo expressed his frustration with regards to not having any reports or information from Susan Gruel or the Business Administrator or the Attorney.

Councilwoman Kilpatrick reminded Councilman Grillo that he sat on the Planning Board and is a professional planner and during that whole time never gave the town an update. Told him to call Susan Gruel.

Council President said that he should call the attorney or the business administrator.

The Borough Attorney informed Co. Grillo that there was an extensive delay in getting the housing plan done properly. He said that although he is not the lead attorney on the COAH matter he has been involved in order to stay informed, so he will reach out to him tomorrow to answer any questions he may have.

### - Charles Lukie, Melrose

Questioned affordable housing units proposed in the Melrose section.

Council President Buchanan said that it has been changed and are waiting to see what the Planning Board approves on Aug.  $2^{nd}$ .

Mr. Lukie commented on the number of cars in the Melrose section and that there is only one road.

Council President Buchanan said that he brought up many concerns for that area.

- Ken Olchaskey, 108 North Edward Street Questioned why wasn't information provided to residents or a town meeting held regarding this housing issue.

Councilman Grillo agreed that the Housing Authority, SERA and maybe some of the environmental committee members should have been involved. Have whole heartedly supported veterans housing on River Road. Expressed that there have been limitations as to what could happen publically. According to law this has to be discussed in closed session.

Mr. Olchaskey disagreed.

Co. Grillo stated that the opportunity for public input was during the public portions on these ordinances. Colleagues asked not to pass the plan, requested they hire a new planner. He felt that the public input was so influential that the original plan had to be scrapped.

Councilpersons Kilpatrick and Novak both said that the plan had to be scrapped because it was not legally noticed.

Mr. Olchaskey went on to express that he felt that they (the residents) had been done wrong.

Councilwoman Novak said that the housing plan was supposed to be done before the planning board before it came to the council. The planning board was supposed to have a public meeting on this housing plan and notice people and this was never done. We're doing that now.

Councilwoman Kilpatrick said that this was done wrong and the council stopped it and is trying to right the ship. She is waiting to find out what August  $2^{nd}$  special planning board meeting will bring. This should be back before the Council on August  $21^{st}$ . This is why we need a secondary planner, because they need to be sure this is done right.

Mr. Olchaskey said that he supports the governing body members who supported the hiring of Susan Gruel.

Councilwoman Novak said that Susan Gruel was the one who found that the governing body never did the housing plan or change the master plan.

# - Janice Benedetto, 1 Thomas Avenue, Melrose

Said that she was the only one on Thomas Avenue that received the mailing. She said that on July  $22^{nd}$  she received two letters. One was certified with green card town off and never signed for. Others on her street were the same. Green cards torn off without signature. So she received a regular letter and a certified letter with green card torn off with no signature. Concerned about neighborhood and put out flyers regarding the planning board meeting.

Council President Buchanan stated that was the law on the mailing to the residents within 200' of the affected property.

She further stated that if any of the residents wanted to review the documents they would have to take time out their business day to review them at borough hall.

Council President Buchanan asked the Borough Clerk to post it on Sayreville.com, our web site.

Ms. Benedetto asked how planning board members become members, their terms, and who is paid.

Council President said that the Mayor appoints the planning board members. Most of the boards and commissions are appointments of the Mayor with the advice and consent of the council. He went on to say that on the planning board the council appoints one representative and last year that was Co. Grillo and this year is Co. Lembo, all other appointments are that of the Mayor according to State Statute with staggered terms. Members are not paid only the professionals.

# - Ruth Mahoney, 2 Gerard Place

Said that she was treated disrespectfully at the planning board meeting. Commented on the 300 marketable units what were proposed for Ernston Road. Commented on a decision of the planning board regarding an application for a four bedroom home and denied because of overcrowding. But these units and others will be built. Asked about how building these marketable units would affect services, and schools.

No further public comment.

Councilwoman Novak made a motion to close the public portion. Motion was seconded by Councilwoman Kilpatrick.

Roll Call: Voice Vote, all Ayes.

Council President Buchanan commented on the actions of the planning board chairman, comments that were made and procedures that were not followed, possibly violating the open public meetings act. The Mayor was not at the last meeting where he was going to ask him (the Mayor) to request the resignation of the Planning Board Chairman. Since he is not here tonight, and there is a procedure the council could follow regarding the planning board chairman's removal. At this time, he asked the Borough Attorney to write a letter to the planning board chairman for him to appear before them at the August 21st meeting for a hearing. He then asked the Borough Attorney to review the procedure.

Mr. DuPont said that there is an ordinance that allows you to hold a hearing and remove the chairman for cause. He will send a letter to the planning board chairman advising him that a hearing will be held on August 21st as to his continuation as a member/chairman of the planning board.

Councilman Buchanan moved the attorney send this letter. Seconded by Councilwoman Novak.
