Mayor O'Brien opened the Council Meeting at 7:03 PM followed by a short prayer and salute to the flag.

Mayors for our Lives – Voter Registration Campaign Initiative

- Presented by Sayreville War Memorial High School Sophomore Umme Alishah

Mayor O'Brien called forward Umme Alishah for her presentation. Miss Alishah introduced herself and explained her Voter Registration Campaign called Mayors for our Lives. She explained that it was a nonprofit organization that began after the Parkland, FL school shooting and students banding together to end gun violence in this Country and in order to do this they have voters register. She said that she is a Chapter Delegate for March for our Lives New Jersey and she said that the Pledge reads that they (the Mayors) will make available voter registration to all local high schools and colleges leading up to and on Sept. 25<sup>th</sup>, which is National Voter Registration Day. Forms will be accessible to students and the Mayors involved will be asked to collaborate with other communities and this will be completely bi-partisan. She said that the youth in the Country are interested in civic engagement now more than ever and by making direct participation in our democracy accessible to them you would be providing them with opportunities for education and involvement. She said that over seventy Mayors from all over the Country have signed the pledge thus far. She said that although she cannot vote she has registered many people and will continue to learn about the process.

- Mayor signed the pledge.

Police Chief John Zebrowski spoke on the issues with regards to the legalization of recreational marijuana in New Jersey. He came to propose an Ordinance to prohibit the recreational marijuana business coming to the Borough of Sayreville. He said he felt it was of great importance to the State of New Jersey. And if it is the Borough's decision that they do not want businesses such as this in Sayreville, he felt it was important to be proactive, to tell our citizens how we feel and that we want to protect them and to tell our State Legislatures that we do not want to see marijuana in the State of New Jersey. He spoke about the long term effects of the use of marijuana and about the use of marijuana in other states where it has become legal and what follows. He went into detail about what it is that we want to prevent. Expressed his concerns from a law enforcement element regarding drugged driving. Spoke about the black market.

He reminded everyone that marijuana is still illegal under Federal Law. In closing he requested the support of the Mayor and Council and that we send a message now if this is what the Mayor and Council want to do. That we want to protect our children, our residents and our motoring public and so what is right for public safety, quality of life and for public health.

Mayor asked if there were any questions of the governing body. -Councilwoman Novak said that she was not in support of it becoming legalized but felt that it would and now we have to look into what we can do legally. She said that she felt that they could not ban the sale of pot throughout the town. She asked the Attorneys to look into if it can be banned if it becomes legal, or if we can limit where it could be sold.

Councilman Buchanan said that he spoke with Assembly Speaker Coughlin over the weekend and they are still working on the bill. He asked if the Council could form a committee of which he would volunteer to work with the Chief, Attorney and Zoning and come up with something that could restrict certain areas if it cannot be banned.

Council President Kilpatrick said that a few months ago Old Bridge forwarded Sayreville a copy of their ordinance regarding this matter. She said that their ordinance was extremely restrictive and basically said nowhere. She wants the council to be pro-active. Likes the committee idea and come up with the best plan for Sayreville. She said that she does not want to see a law passed on the State level and Sayreville try to put restrictions on after the fact then find out that we would have needed that to be on the books before the State Law passed. We need zoning and protection for our town. She doesn't want the committee to be a stalling mechanism.

Councilman Lembo commented that this would not be a Zoning issue. He does not want to see it sold anywhere in town. Comments followed regarding if it would be a zoning/land use matter or not.

The Borough Attorney said that there have been a number of towns that passed a Resolution prohibiting marijuana in their town. Other towns that have amended their ordinances to make it difficult to or impossible to sell, distribute or grow within their town. He said that the bill has been changing so he does not know what powers the bill will contain that will preempt anything the council does. He said that the committee was important to get on the ground as to alternatives be it a resolution, an ordinance or a zoning change. They all need to be looked at and discussed.

Councilman Grillo said that he is the progressive liberal. He said that he does not support anything that does not call for the legalization of marijuana. He said that he was a delegate of the Democratic Convention for Bernie Sanders to support this. He supported John Wisniewski which was a major point of his campaign.

He volunteered to be on the committee with Councilman Buchanan. He went on record with his points. He does not believe that this is something that they should support, he would respectfully would vote "No" if this was any type of an adjustment to the zoning code and legalizing it will not make it any more dangerous that people who drink and drive and it is illegal to drive under the influence of marijuana and a warrant can be requested to take a blood test of someone suspected to be driving under the influence. He said he wants work collaboratively with his colleagues.

Mr. DuPont said that all of these efforts may be in vain depending on what the bill says about preemptive rights of State Legislature. So we need to form, discuss and look at the bill. Mayor said that we need to get started so he appointed Councilman Buchanan, Grillo and Lembo to review the matter.

Mayor said that this is a topic in which the public wants their voices heard. He scheduled a Public Meeting for September 25<sup>th</sup> at 7PM in the Council Chambers.

He hopes that by that time the committee would have come together and done their research. At that time, he would like to hear from the residents of Sayreville. Mayor spoke about Home Rule and Blue Laws.

Councilman Lembo said that he felt it would benefit Sayreville to be ahead of the curve and pass a resolution and send a message to the State that this is not what we want.

Councilman Buchanan said that if they just pass something just to pass it we could end up like the COAH matter. He would rather have it researched and have the right plan and do the right thing.

Councilwoman Novak said that she would rather pass something that has teeth to it. We need to do whatever we can to get out ahead of this and get something in place right now.

#### **MOMENT OF SILENCE**

- Mayor asked for everyone to reflect on the horrific event that took place seven-teen years ago, 9-11 and the 3,000 that last their lives that day. He called for a Moment of Silence.

A moment of Silence was observed by all in attendance.

- Mayor opened the meeting to the public on the retain matter of marijuana.

Those appearing were:

- James Robinson, 11 Borelle Square

Spoke about the matter of medical marijuana and the distinction between medical and recreational marijuana. He asked that the council look favorably upon medical marijuana.

Councilman Grillo said that when the committee meets they will have to distinguish between medical and recreational marijuana and also look at the agricultural aspect.

- Aubrey Novarro-Conway, 2301 Timber Ridge Ct. Asked the Council to keep in mind that medical marijuana serves so many patients – Veterans, children, and many other everyday people that rely on medical marijuana.

- Steve Melaneski, Scarlett Drive He said that we do need to get in front of this issue. Stated that there are two avenues – list both the pro's and the con's on each side.

#### - Mike Brentdrive, Howell

He said that he is here to be a resource and spoke in favor of medical marijuana and how it helped his son as he battled brain cancer for five years. He said that he was sent home with the best of drugs but they were not good enough. The only thing that was efficacious enough to keep Jake comfortable was medical marijuana. And the distance he would have to travel to obtain the medical marijuana.

Mayor asked that he send him any information regarding medical marijuana as would be a useful tool.

Mayor asked the Council if anyone sitting had an issue with medical marijuana. They all responded that they did not recreational only.

Mike DuPont spoke about a seminar he just attended regarding medical marijuana and the issues discussed at this seminar.

Councilman Grillo said that there may be another resource we could employ and perhaps Dan could take care of this. He said that earlier this year Senator Sanders introduced the Marijuana Justice Act. He said it is co-sponsored by Senator Booker. So if he would reach out to their staff they may be able to provide resources and information that would be useful to help the committee understand the differences.

#### - Jeffrey Oats, Ocean Port, NJ

In support of medical marijuana and spoke about how it helped him personally with his cancer. Asked the governing body to take action and pass a resolution to support med cabanas and medical research and education this is more than a pot shop on the corner this is going to be the future.

- Angela Colandrea, 15 Ridge Avenue and co-owner of Nunzio's Kitchen.

She spoke in support of medical marijuana.

- Tom Biesiada, Parlin

He has no problem with medical marijuana not just for recreational use.

He asked that someone from the town be on the committee, also asked that the Board of Education sit on dais at the special meeting.

Mayor said that he would reach out to the Board of Education to be part of the meeting on Sept. 25, 2018.

Council President Kilpatrick asked that some of the Student Assistant Counsellors also attend the special meeting so they could bring in their knowledge.

- Hugh Giordano, Blackwood, NJ

Said that he is attending as a union representative of United Food & Commercial Workers Union Local #152. He stated that his union represents both adult use and medical use workers in States that have legalized it for medical and States that have legalized it for adult use. He stated that he is here in support of both medical and adult use and call a ban on either one on an attack against the working class and middle class. He presented some statistics and facts on both uses and represented that it is a job creator. He also indicated that the Council has 90 days after the law is passed to pass a resolution or an ordinance in support or not.

- Ken Olchaskey, 108 North Edward St.

He stated that if legalized it is a State moneymaker. Expressed his concerns over the many problems legalizing it may create. Thought we should adopt an ordinance that could protect us now and that it could always be amended.

- Lefty Grimes, East Hanover, NJ

He commented about the different people that come out to meetings on topics like this. He also made statements and had questions regarding the comments the Police Chief made in his presentation.

- Adole Switzer, Old Bridge, NJ, formerly from Sayreville.

She said she is a NJ medical marijuana patient.

Commented on the passing of recreational marijuana and spoke in favor of it and that people could benefit from recreational use marijuana.

- Richard Moroski, Spotswood, NJ

He said that all marijuana is medical. He spoke on how he has benefitted from the use of marijuana. He implored everyone to investigate, explore, educate before making a decision.

- Phil Emma, Parlin, NJ

Commented on the number of out of towners commenting here tonight. He asked if the committee that is being formed is open to Sayreville residents.

Mayor stated that it was not at this point.

- Charles Lukie, Oak Street, Sayreville, NJ

He asked that the committee that was formed contact the States that have it legalized and gather the pro's and con's since they have legalized marijuana.

- Jeffrey King, Eatontown, NJ

Spoke in favor of recreational marijuana.

Stated that recreational marijuana was a matter of social justice and civil rights. It is a matter of individual liberty and that this is America and we are free to do what we want as long as we do not harm anyone. He commented on the number of people that get arrested and that this is not a violent thing.

He did not agree with the police chief on a lot of his comments. He suggested a resolution encouraging a medical dispensary and encourage the ending of the arrests surrounding marijuana.

There were no further questions or comments.
