2. That the Borough Clerk is authorized to insert a brief notice in a daily newspaper circulating in Middlesex County once a week for two consecutive weeks giving public notice of the final acceptance of said work so that any potential lien claimants may have notice thereof.

3. That upon expiration of the 45 days from the date hereof, the proper municipal officials be and they are hereby authorized and directed to execute and deliver a check to the said contractor covering the amount due him, less any retained percentage authorized by the contract documents.

4. That should the contract under which this work has been done provide for the release of any retained percentage upon the filing of a maintenance bond, that said percentage shall be paid said contractor upon the filing of a one-year 15% Maintenance Bond in the amount of \$56,084.66 and the approval of same as to form and sufficiency by the Borough Attorney.

At this time Mayor Kilpatrick opened the meeting to the public for questions or comments on any and all matters.

Those appearing were:

- Arthur Rittenhouse, 33 Delikat Lane

Mr. Rittenhouse asked the status on Fulton's Landing.

Borough Attorney DuPont stated that there is nothing new.

Mr. Rittenhouse commented on opening of the building for the election center. Mayor stated that all possible locations were looked into and there was a lot more involved than just a location. She stated the purpose is that the voters feel empowered and have the understanding in order to vote. Mayor stated that the voters would only have access to council chambers.

Mr. Rittenhouse questioned who would be staffing the election center. Mayor responded it is the County Clerk's office.

He questioned who is paying for the use of the building.

Business Administrator Frankel stated that the Borough is not incurring any cost. Mr. Rittenhouse commented on the lawsuit filed against the Borough in the newspaper.

- Jeff King, 24 Elizabeth Parkway, Eatontown

Mr. King stated that he saw an article quoting Chief Zebrowski that it's in his role of head of the Chiefs' Association and campaigning against legalization of marijuana.

Mayor stated for him to contact the Chief regarding his comments. Mr. King stated he takes issue with him being a lobbyist as an employee of the Borough and that it is inappropriate and he should resign if he's going to be campaigning.

- Patrick Duff, 210 7th Avenue, Haddon Heights

Mr. Duff stated that there have been about 40,000 NJ residents that have been arrested for marijuana. He stated that the town would be safer if the police have the ability to go after people who are violent criminals.

Mayor stated that this is something that will be voted on by the people of NJ. Mr. Duff questioned if there is a policy for social media for officials.

- Edward Grimes, 213 Avenue B, Bayonne

Mr. Grimes stated that he's spoken with Police Officers and Chiefs and a lot of them don't agree with Chief Zebrowski. He questioned why the Police Chief is allowed to speak on this matter. He called on Chief Zebrowski to resign.

- Lee Mullican, 18 Gavel Road

Mr. Mullican commented about opening the building to voters with Covid cases increasing.

Mayor responded that there will be specific entrance and sanitizing procedures that will be taking place. She stated voters will only be allowed in council chambers because the people need to be informed and help with question regarding the election.

- Sharry Rodas, 20 Second Street

Ms. Rodas stated that she had sent several emails to the Mayor regarding the election and hasn't received a response. She commented that the Borough is concerned with residents that live outside of Sayreville with Covid cases rising. Mayor responded that she didn't see any of her emails and that every single resident or non-resident deserve to have information from an official that handles the election process.

Ms. Rodas stated that there is major drug dealing happening on her street and the residents are begging to have street lights put on the street because of crack dealing going on. She also stated that the Mayor didn't respond to that residents email either.

Mayor responded that she has responded to multiple residents regarding situations on Second Street but had the Police Dept. make that a point of priority and they have gone to residents home in that area in regards to that issue.

- Anton New, 23 Heather Way

Mr. New agreed with the election service station to Sayreville and Middlesex County to increase voter awareness is essential. He questioned if there were any initiatives or compost recycling to the county.

Mayor responded that she doesn't know of any current initiatives to bring in composting.

Council President Novak stated that there is nothing town wide for composting. She stated it is something they would like to look into.

Councilwoman Maher stated she hasn't heard composting being brought up by the Environmental Commission but is something she will bring up at their next meeting. She stated the community garden was brought up at their last meeting and are in the process of researching other towns in hopes of having one in Sayreville.

- Mark Hurley, AFSCME President

Mr. Hurley commented about the election center and that he's received some questions and concerns from the union members at Borough Hall. He questioned if the Borough has a written policy of how things are going to be handled and if he could be included on how to keep the members/employees safe.

Mayor responded that the employees are always their main focus and to make sure that they are comfortable.

Business Administrator Frankel stated that he spoke with about 75% of the employees in the building letting them know what was going on but would put it in writing to him.

No further comments.

Mayor Kilpatrick called for a Motion. **Council President Novak made a motion to close the Public Portion. Seconded by Councilman Conti.**
