A RESOLUTION OF THE BOROUGH OF SAYREVILLE IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, EXPRESSING SUPPORT FOR TRANSPORTATION ELECTRIFICATION IN THE STATE OF NEW JERSEY

WHEREAS, emissions from gasoline and diesel-powered vehicles contribute significantly to air pollution, including global warming emissions, ground-level ozone, fine particulate matter;

WHEREAS, numerous scientific studies have found links between exposure to fine particulates and health effects including premature death, and increased incidents of asthma, allergies, and other breathing disorders, including groundbreaking research from Rutgers Environmental and Occupational Health Science Institute (EOHSH);

WHEREAS, New Jersey is especially at threat from the impact of climate change, with more than 300,000 people in coastal areas in danger from rising sea levels, flooding, and dangerous storms;

WHEREAS, New Jersey is warming at twice the rate of the rest of the United States because of fossil fuel use, leading to dangerous environmental and public health impacts;

WHEREAS, petroleum-based gasoline and diesel fuel are non-renewable fuels, and for every gallon of gasoline used, the average car produces about 20 pounds of carbon dioxide (CO2), the largest contributor to climate change nationally and in-state;

WHEREAS, more than forty (40%) percent of energy-related greenhouse gas emissions in New Jersey are from the transportation sector, with about half of that twenty (20%) percent from fossil fuel-powered cars;

WHEREAS, increased adoption of electric vehicles and the charging infrastructure to support them is an effective way to reduce climate-heating greenhouse gas emissions and improve air quality;

WHEREAS, the Borough of Sayreville wants to be prepared to take advantage of the rapidly expanding market in electric vehicles and the growing range of funding sources for transit electrification;

WHEREAS, the Borough of Sayreville is committed to fostering sustainability and ensuring a healthy environment for present and future citizens; and

WHEREAS, the Trump Administration's proposed rollback of the Clean Cars Program and attack on the ability of states like New Jersey to set their own emissions standards, it is more critical than ever for counties like Middlesex County support the goals of the New Jersey Clean Cars Program to put more than 330,000 electric vehicles on the road by 2025 to reduce air pollution and carbon emissions; and

WHEREAS, it is essential to pass S2252/A4819 to install at least 600 public DC fast chargers and Level 2 public community chargers at 1,000 locations or more across the state by December 31, 2021 as soon as possible; and

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Sayreville, County of Middlesex and State of New Jersey supports the electrification of transportation and welcomes investment in electric vehicles and electric vehicle supply equipment by agencies public and private; and

Council President Buchanan opened the meeting up to the Public for questions or comments. Those appearing were:

- Amy Cohen, Fanwood, NJ

She is speaking on behalf of her husband, Larry, who is a volunteer legislator of the Humane Society of NJ and was committed to speak in another town, so she is here to read a statement he prepared.

She thanked the Mayor and Council for joining in with the 139 towns in NJ along with 100's more States around the Country regarding the broken business model where profits come at the expense of tortured and dead animals and that it has no place in Sayreville. This ordinances welcomes to the town any store dealing with pet supplies and services including PetCo, Pet Smart and 24 of the largest 25 pet store chains in the County, which already refused to sell dogs and cats because they know that supply chain is polluted with inhumane puppy mills. She said only Pet Land among the big chains sells dogs and cats and they have no stores in NJ. She said that if you were to google this store the public would be appalled at the results. She went on to claim other mis-justices regarding animal cruelty as well as a pet store in Union County with defining violations and abuses of the animal welfare act (which can be found in this minute mile). She said that this ordinance is one against animal cruelty and one in which we hope Sayreville will be very proud and adopt. She handed out information packets to the Mayor and Council.

- Art Rittenhouse - 33 Delikat Lane

Spoke regarding the Fulton's Landing property and the possible contamination that is on that property. He commented about a Notice of Violation from the State Dept. of Environmental Protection to an OPRA Request. #PEA 19001-1U3011 Lack of a Permit, Storage of Soil that is mixed with and discarded asphalt. He said that a review of the analytical results received by the Dept. for imported soils to these properties reviled the soil has exceeded an hazardous contaminant of NJ Residential of direct contact soil remediation standards and or the NJ Non Residential Direct contact soil remediation

standards. He proceeded to name some of the chemicals that were detected. He expressed concerns about it draining into the water supply or into over 600 homes. He described what these chemicals were and that Permits have not been checked. He hoped for the Council to do something for the residents.

- Mike D'Addio, SERA Chairman

Mr. D'Addio said that the Borough attorney is in receipt of a testing report that was completed this year which gave it a clean bill of health and brought it up to Non-Residential Standards so that the property could be built upon. He also reiterated to the Council and to Mr. Rittenhouse that SERA would have the land tested when it comes before SERA. Nothing will be built on it and if there is anything contaminated on there, just like at Riverton, it will be removed. He said that he is not aware of any asphalt upon that property. SERA will do their own independent testing and be cleaned up if there is anything contaminated in the soil.

- Art Rittenhouse, 33 Delikat Lane

He stated that a report he read was from the DEP dated October 7, 2019. And they have 30 days to prepare their report on how to clean it up.

- Darrel Hartsfield, 104 Sayreville Blvd. He commented on the Rent Leveling Board Ordinance that was passed without the Rent Leveling Boards comment or approval.

Mr. DuPont said that he spoke with Mr. Nolan who is the Rent Leveling Board Attorney regarding this ordinance and he indicated that the Rent Leveling Board was advised and did support the changes.

Mr. Hartsfield stated that was incorrect. He said that in May, Mr. Nolan's Associate said that they were in consultation and would get back in touch with them in two weeks and the board hasn't heard since.

Mr. DuPont said that he would follow-up with Mr. Nolan tomorrow and would report back to the Business Administrator.

No further questions or comments.

Councilwoman Novak made a motion to close the public portion. Seconded by Councilman Dalina.

Roll Call: Voice Vote, all Ayes.

Before closing Councilwoman Kilpatrick asked that Mr. Hartsfield put in writing anything that the Board is opposed to regarding this ordinance. Mr. Hartsfield stated that he wasn't sure if the Board was opposed but not sure why there were not part of the process.
