Combined Meeting of the Mayor and Borough Council held on Monday, December 16, 2013, in the Borough Hall, 167 Main Street, Sayreville, was called to order by Mayor Kennedy O'Brien 7:04 P.M. followed by a short prayer and salute to the flag.

At this time Mayor O'Brien called for council remarks to Councilman William Henry on his last meeting as Councilman.

Good Will Comments made by Councilwomen Novak, Eicher, Councilmen Melendez, McGill, Buchanan.

Mayor then called upon Councilman William Henry for his remarks.

Councilman Henry thanked the residents of Sayreville for allowing him to serve these past three years. He said that it has been an honor and a privilege. He felt they did a good job in controlling taxes and curtailing over one million dollars in wasteful spending. He said that taxes only went up 1% per year these past three years, which is lower than inflation. They supported the First Responders with the equipment they needed to protect the residents of Sayreville and themselves. He announced that the parking lot at Melrose Fire House was finally completed. The tennis courts at Kennedy Park were refurbished and these are just a few accomplishments during his service. He thanked Wayne Kronowski for his guidance on the budget and financial matters; Dan Frankel to his dedication time and effort after Super storm Sandy hit; to the professionals on the Dias Jay Cornell, Mike DuPont – you are both so knowledgeable and handle yourself with extreme professionalism; Terry Farbaniec - you know the Borough of Sayreville and help him immensely-thank you; thanked all of the employees of Sayreville as they do a terrific job with the limited resources they have. It has been an experience working alongside of the Mayor and Council and thank you for your guidance and support; and many other people he came in contact with that he thanked for their advise and friendship. He commented on some projects such as the Main Street By-Pass, understanding that some residents are opposed to the project with concerns about truck traffic, noise, children's safety and others. He commented on the traffic on Main Street now but is concerned about the traffic when 600,000 sq ft. of warehousing is built with 100 bays on 50 acres and the expressed concerns on the number of trucks it could generate every day, with another 100 acres to be developed for light industry. So how many more cars and trucks will be using Main Street. Even with the 200,000 sq foot Bass Pro Shop coming could generate One and One Half Million to three Million shoppers per year and questioned how shoppers from South River, East Brunswick and others south west travel there. So he believes the residents will need the additional access road. He expressed his concern about some condo's only having one access in and out. Traffic is not going to get any better, we need the By-Pass. He suggested the leadership of Sayreville try and take action, although a long shot with regards to the approved warehouses. Perhaps talk to the owners and developers to see if a different use can be worked out, something that would benefit everyone using the entire 150 acres. Perhaps a retirement complex that has multiple roads in and out of the village, not just one on Main Street. He felt the governing body could sit down and work out a solution that benefits all of Sayreville. Felt the Mayor and Council has a lot of power when it comes to Land Use such as changing zoning, buying land under Open Space program and under

eminent domain. Residents need to know what their leadership thinks and what their opinions are. Residents need to demand action from their leadership. There are many projects in the works that will affect the town forever. You need to know that the leadership is working in the best interest of the residents. He said that he enjoyed being on the Council but feel bad that he will not be there to see these projects come to reality. He thanked his wife Noreen for the times he left her alone while he attended meetings and events. These are things that they could not have done without a commitment from their spouses. Thank You all.

Remarks made by Mr. Adam Rosinski

ORDINANCE #240-13

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XXXIII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF SAYREVILLE TO ADD SECTION 33-11 "TOTALLY DISABLED VETERAN'S TAX EXEMPTION"

BE IT AND IT IS HEREBY ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the county of Middlesex, that the Revised General Ordinances of the Borough of Sayreville are hereby amended as follows:

This Ordinance amends Chapter 33 of the Revised General Ordinances of the Borough of Sayreville by adding Section 33-11 entitled, "Totally Disabled Veteran's Tax Exemption" as follows:

STATEMENT OF PURPOSE OF ORDINANCE

The ordinance above supplements Chapter III, Finance and Taxation, of the Revised Ordinance of the Borough of Sayreville, with the revision of Section 33-11, 100% Disabled Veteran Tax Refunds. The ordinance establishes a formal policy providing that a retroactive refund of property taxes as set forth in N.J.S.A. 54:4-3.30 and the prior year, but in no event greater than thirty-six (36) month period in the aggregate.

33-11 TOTALLY DISABLED VETERAN'S TAX EXEMPTION.

- a. The Borough of Sayreville will allow for either a veteran or surviving spouse of a veteran to obtain municipal property tax relief upon proper claim. An eligible veteran shall be defined as a member of the armed forces who was either honorably discharged or released under honorable circumstances from active service in the time of war or has been declared by the United States Veterans Administration to be One Hundred (100%) percent, permanently disabled.
- b. In order to qualify for the municipal tax exemption, the veteran or someone legally on his/her behalf under oath must file a written claim with the tax assessor's office. The tax assessor's office will supply the applicant with the appropriate paperwork and the applicant will be required to provide the tax assessor's office with the following information:
 - 1. Reason for the exemption;
 - 2. A description of the property for which the exemption is claimed;
- 3. A certificate of claimant's honorable discharge or release under honorable circumstances from active service, in time of war and a certificate/letter from the United States Veteran's Administration or its successors, certifying to a service-connected disability.
- c. In order for a surviving spouse of a veteran to qualify for the municipal tax exemption, the spouse, under oath, must file a written claim with the tax assessor's office. The tax assessor's office will supply the surviving spouse with the appropriate paperwork and the applicant will be required to provide the tax assessor's office with the following information:
- 1. Proof to establish that the spouse is the owner of legal title to the premises on which the exemption is made;
- 2. That the claimant occupies the dwelling house on said premises as the claimant's legal residence in the State of New Jersey;
- 3. That the veteran has been declared by the United States Veterans Administration to have a service-connected disability or that the veteran shall have been declared to have died in active service in time of war;
- 4. That the veteran is or would have been entitled to exemption at the time of death;
 - 5. The claimant is a resident of the State of New Jersey who has not remarried.

33-11 100% DISABLED VETERAN TAX REFUNDS.

33-11.1 A retroactive refund of property taxes as set forth in N.J.S.A. 54:4-3.32 shall be limited to the current year of the submission of a proper claim to the tax assessor as required by N.J.S.A. 54:4-3.30 and the prior two years, but in no event greater than a thirty-six month period in the aggregate.

- **Section 2.** The Borough Tax Assessor, together with all other appropriate officers and employees, are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Ordinance.
- **Section 3.** All ordinances of the Borough of Sayreville which are inconsistent with the provisions of this Ordinance hereby repealed as to the extent of such inconsistency.
- **Section 4.** In any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any Court of competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.
- **Section 5.** This Ordinance shall take effect immediately upon final passage, approval and publication as provided by law.

BE IT FURTHER ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, that **Chapter Thirty Three, Tax Exemptions and Abatements,** of the Revised General Ordinances of the Borough of Sayreville, shall also be amended to reflect said change.

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed and this Ordinance shall take effect immediately upon final passage and publication in accordance with law.

BE IT AND IT IS HEREBY ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, State of New Jersey, that the Revised General Ordinances of the Borough of Sayreville are hereby amended as follows:

17-4 - MUNICIPAL BOAT LAUNCHING FACILITIES

a. *Eligibility*. Persons *eighteen (18)* years of age or older, both residents and nonresidents of the Borough of Sayreville, shall be eligible to use the *Buchanan Waterfront Park* subsequent to complying with the requirements set forth hereunder.

b. *Registration.* Applicants for permits to use the *Buchanan Waterfront Park* shall furnish the Office of Recreation with the following information: their name, address, description of their boat(s) or other watercraft, license number thereof and license *number* for any trailer to be used in connection with launching and hauling out. All required licenses and registrations must be current. Other information may be required by order of the Mayor and Council or other authorized agency.

c. Permits.

- 1. All required permits shall be serially numbered for identification purposes. The serial number of each such permit shall be entered in a book for registration thereof opposite the name and address of the permit holder. Permit holders engaged in launching or retrieving their boat or other watercraft shall at all times have their permits visible. *One (1) permit shall be placed on the trailer and one (1) permit on the boat or watercraft.*
- 2. Permit Fees—Registration. Permit holders *eighteen (18) years of age or older* must present current *license* and registrations, which clearly state the permit holder's name and address, for each of the following: *driver's license*, *boat or watercraft registration and trailer registration*.

- d. *Facility Rules and Regulations*. The Borough Recreation Advisory Board shall promulgate rules and regulations governing the use of the boat launch facility and same shall be posted on-site and shall also be distributed to all permit applicants and daily applicants at the time of registration. Failure to comply with these rules and regulations, especially as impacts safety, shall be cause for the possible forfeiture of the offender's permit to use the facility. Daily users may be barred from future use of the facility *and tickets issued under violation and penalties.*
- e. Signs. There shall be signs posted at the Borough's boat launching facilities stating:
 - 1. BOAT LAUNCHING FACILITIES SHALL BE OPEN FROM JANUARY 1 TO DECEMBER 31.

a. Daily permits issued during normal operating hours from Memorial Day to Labor Day at Buchanan Waterfront Park. From Labor Day to Memorial day at the Recreation Office 8am to 4pm Mondays to Fridays only. Weekend users from Labor Day to Memorial Day must get their permits during the week at the Recreation Office. All daily permits must be displayed on drivers side dashboard.

BE IT FURTHER ORDAINED by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, that **Chapter XVII**, **Section 17-4 Municipal Boat Launching Facilities**, of the Revised General Ordinances of the Borough of Sayreville, shall be amended to reflect such change.

WHEREAS, a redevelopment plan entitled "Borough of Sayreville Landfill and Melrose Redevelopment Plan" has been prepared and presented to the Governing Body for review and consideration; and

WHEREAS, the Governing Body desires that the Borough of Sayreville Landfill and Melrose Redevelopment Plan become the formal planning document for revitalization of the Borough of Sayreville Landfill and Melrose Redevelopment area.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Sayreville, County of Middlesex, State of New Jersey, that the Redevelopment Plan, attached hereto a Rider "A" is hereby adopted as the Redevelopment Plan for the Borough of Sayreville Landfill and Melrose Redevelopment Plan as defined within the Plan; and

5.29-1.1 LICENSE REQUIRED

- A. It shall be unlawful for any nonexempt person or organization to engage in any of those practices regulated by this section without having first obtained a license therefor in accordance with the applicable provisions of this section.
- B. The Borough Clerk shall maintain a list of names and addresses of residents who have determined that solicitors, peddlers and/or hawkers shall not be invited to their respective residence. Any resident shall be included on such list if they complete a form to be so included. The form shall be available at Borough Hall. The list shall be distributed to applicants seeking a license for the purposes mentioned herein. The licensee shall not solicit, peddle or hawk at any residence on the list. Any solicitor, peddler or hawker who goes upon any premises or rings a doorbell upon or near any door or creates any sound in any manner calculated to attract the attention of the occupant of such residence, when such residence is on the list provided shall be considered to be engaging in uninvited soliciting as set forth in Section 5.29-1, and shall be subject to the penalties set forth in Section 1.5 of the General Ordinances of the Borough of Sayreville. Religious and educational groups and not for profits registered within the Borough shall be exempt.

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed and this Ordinance shall take effect immediately upon final passage and publication in accordance with law.
