We have received all of the appraisals for this project. Several property owners have signed off on the easements, however, a great number refused. Therefore, a public taking of the property is necessary. I am meeting with Mike DuPont and another member of his firm on 7/11/11 at 4:30 to finalize the details. At worst case scenario the ordinance will be completed by the attorney's office for introduction at the 7/25/11 meeting.

Approximately 165 applications were received for this position. Of those 24 were Sayreville residents with CDLs. Bernie Bailey and I selected 10 of the 24 for interviews based upon their application/resume. Nine of the 10 applicants could be accommodated with interviews due to scheduling issues. Councilman Henry attended the interviews in place of DPW Committee Chairman Buchanan. Bernie and I have reduced the 9 to 4 candidates. I have provided the police department with information on each candidate for their review with our internal police records. That report will be available to me on Monday in preparation for Bernie and me to make a final recommendation in closed session this meeting.

- b. Police Department

Chief Zebrowski and the police department has reviewed the RICE list provided by the state which includes all of the recently laid off officers. They specifically focused on Sayreville residents as permitted by the statutes surrounding the list. Background checks were completed and at this point they are recommending the Borough hire Mr. Mr. Michael A. Pascone. We have not hired through this process before and are looking for direction as to whether the governing body would like to conduct a separate interview with this one person. In the past, the governing body does interview several candidates for the civil service list during the hiring process. However, in this case the candidate is already civil service certified and is obviously in a current pool of one. I recommend that you still interview as a matter of course. If that is your direction we will seek to schedule for the July 25th meeting. The Chief will be available for executive session this Monday evening for any questions you may have. I have also enclosed a copy of a letter from the Chief with additional information on this topic.
