ORDINANCE #493-20 CALENDAR YEAR 2020 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

It is the intention of this subsection that non-voting members shall serve as advisors to the Board so that the Board may benefit from the business experience of the non-voting members. Non-voting members shall be appointed by the Mayor with advice and consent of the Borough Council. Non-voting members shall be appointed for a term of three (3) years or until their successor shall be appointed and qualified.

All members of the Commission on Aging shall serve without compensation.

At this time Mayor Kilpatrick opened the meeting to the public for questions or comments on any and all matters.

Those appearing were:

Mike D'Addio, SERA Chairman
Mr. D'Addio questioned where they were at with the Rent Control Ordinance. He stated some applicants/projects that were done were not bound by the ordinance.
Mayor Kilpatrick stated since her time up there they have never allowed a

developer to ignore the ordinances or rent control.

Borough Attorney DuPont stated there have been no exemptions.

- Arthur Rittenhouse, 33 Delikat Lane

Mr. Rittenhouse thanked them for the Arbor Day Proclamation and that there celebration will be April 25, 2020 at Kennedy Park from 8am until 12 noon. He stated they are having their 3rd Annual Shade Tree Art Contest on March 27, 2020. Mr. Rittenhouse stated he spoke with Jessica McGrath the representative from the DEP on Fulton's Landing. He stated that the DEP's job is to make sure Fulton's Landing hires a company to check the soil and remove any of the contaminated soil. He stated that the mining permit has nothing to with the Borough ordinances and we should have been collecting money from them all the time they were bringing the dirt in as well as when the dirt was going out.

- Christina Davis, 92 Miller Ave.

Ms. Davis thanked the Council for putting Section (b) back into Ordinance #497-20. She stated removing (f) in there still removes the checks and balances because there is no annual contract.

Councilman Enriquez stated that they will be checking on the organizations constantly to make sure everyone is maintaining their standards.

She questioned if the subcommittees ever came to because they never heard anything back on them.

Councilman Enriquez stated the Recreation Dept. looked into everything instead of having a subcommittee.

She stated that an organization was left off that review and sent an email to Councilman Enriquez.

Councilman Enriquez stated he never received that email.

Ms. Davis questioned Ordinance #498-20 with regards to the fee schedule remaining the same. She stated that she reached out to the DEP regarding the fees. She said the cost that Sayreville charges is almost double in most cases.

Business Administrator Frankel stated that he disagrees with her and that the DEP stated that they were in line with surrounding towns.

Ms. Davis stated that it is cheaper for a Sayreville resident to get a permit in a surrounding town at the non-resident rate than as a resident in Sayreville.

- Tom Pollando, 15 Oakwood Dr.

Mr. Pollando stated he wanted to submit to the Council the Sayreville AA's 2019 taxes and the requirements are now complete. He stated that Sayreville Soccer Club's taxes from 2015, 2016 and 2018 have not been sent in.

- Randy Litz, 99 Main Street

Mr. Litz stated that the parking has increased in the last two weeks. He stated that he met with Sgt. Braile and he was going to bring it up to the Engineer about putting parking spot lines on Main Street. He questioned who would be enforcing the parking because it's not being enforced now. He stated that he was told he could start writing tickets and submit the pictures to court.

Mayor Kilpatrick asked the business administrator to meet with the Police Chief and Sgt. Braile to find a remedy. She stated the request hasn't reached our Engineer's office yet and will continue to work to get remedy to this situation.

- Fred Block, 25 Calliope Road

Mr. Block stated the ordinance regarding the fees for Sayreville residents to get access to the parks and putting them almost last. He stated to charge the residents is kind of insulting to the residents. He asked them to think about it.

Councilman Enriquez stated he thinks there is a misconception on the charging. He stated the fields are opened to the public during the operating hours of the park free of charge. He stated there is only a charge if you need a field at a structured level where games and practices are being held.

Mr. Block questioned what was needed to become a municipally sponsored organization. Mayor Kilpatrick stated that she will get that information to him.

Councilwoman Maher stated that there was incorrect information out there about the schools being charged and that is not true.

- Tom Pollando, 15 Oakwood Drive

Mr. Pollando stated that he has concerns about the permits because they are looking to start practicing.

Councilman Enriquez responded that they were going to wait until the ordinances are passed but the Recreation Dept. will start issuing the permits soon.

- Bob Corby, 6 Evelyn Terrace

Mr. Corby handed out invitations inviting them to Sayreville Little League's Opening Day on April 18th.

Borough Attorney DuPont stated they did send correspondence to the DEP for an update on Fulton's Landing and was informed that Brinkerhoff Environmental has been retained and is working on the site. He asked that DEP or Jessica reach out to him and it is his understanding that there have been geotechnical activities on the site. He hopes to have additional testing.
