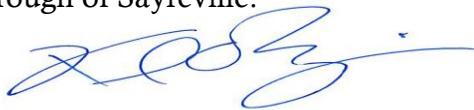

WHEREAS, on July 6, 2015, the Borough of Sayreville (hereinafter "Sayreville" or the "Borough") filed a declaratory action with the Superior Court of New Jersey pursuant to In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015) (Mount Laurel IV), entitled In the Matter of the Application of the Borough of Sayreville, County of Middlesex, Docket No. MID-L-4010-15 seeking, among other things, a judicial declaration that its Housing Element and Fair Share Plan, to be amended as necessary, satisfied its "fair share" of the regional need for low and moderate income housing pursuant to the "Mount Laurel doctrine;" and

WHEREAS, in connection with this lawsuit, the Borough simultaneously sought, and ultimately secured, a protective order providing Sayreville and its Planning Board

immunity from all exclusionary zoning lawsuits while the Borough pursued approval of its Housing Element and Fair Share Plan, which is still in full force and effect; and

WHEREAS, an issue arose in the declaratory relief action concerning whether the Borough ever authorized the execution of an agreement with Fair Share Housing Center, Inc. (FSHC) and K-Land Corporation (K-Land), resulting in the Borough filing of a motion to acknowledge that there was no agreement and that the Borough was free to satisfy its Mount Laurel obligations free from any limitations from the purported agreement; and

WHEREAS, prior to the Court ruling on the Borough's motion, the Borough engaged in litigation with FSHC, K-Land and National Lead, Inc.(NL); and

WHEREAS, as a result of those negotiations, the Borough entered into separate settlement agreements with FSHC, K-Land and NL; and

WHEREAS, at the insistence of K-Land and NL, the Sayreville Planning Board (Planning Board) also is a named party to these settlements; and

WHEREAS, the Planning Board has adopted an amended Housing Element and Fair Share Plan (affordable housing plan) incorporating and implementing the three settlements; and

WHEREAS, the Borough wishes to endorse said affordable housing plan.

NOW THEREFORE BE IT RESOLVED, BY THE Governing Body of the Borough of Sayreville in the County of Middlesex, and the State of New Jersey hereby endorses the Amended Housing Element Fair Share Plan, adopted by the Planning Board on June 13, 2018.

- **PUBLIC PORTION**

At this time the Mayor opened the meeting to the Public for questions or comments on any and all matters.

Those appearing were:

Ken Kurczeski, 17 Pershing Avenue

Appearing on behalf of his mother and father of 17 Pershing Avenue requesting the "No Parking" signs that were put up on Wednesday be removed until such time as the residents can be heard from. He also went on to talk about the issue that there have been no improvements ever being made to the street.

The Mayor asked the Engineer to address the capital improvement issue. Mr. Cornell explained that as part of Hercules Village Area Improvements. First, there would be Water and Sanitary Sewer Improvements which should be starting this month and then next spring the roads will be reconstructed with curbs, no sidewalks.

He said that most of his concern at this point was that they had no knowledge of this ordinance and sign. He said that this sign creates a burden for both of his parents. He said that the zig zag parking on the street slows people down. Further expressed his concerns about cars speeding with no one parked on both sides with the Zig zag pattern.

He did say that his father has a driveway, however his father cannot turn his head enough to safely back out. He stressed that the council leaves it up to the residents of Pershing Avenue to make this decision.

Mayor said that there are two things he is looking to accomplish as a policy.

1) When there is an ordinance affecting a residential street that the residents be notified.

Mayor asked if there were any objections to this change of process. None heard.

2) Form a committee to meet with the residents of Pershing Avenue for their input. He then asked Co. Lembo, Buchanan and Grillo be part of this committee. He also requested that the police attend, Mr. Krushinski.

Councilwoman Novak stopped the Mayor and asked the Borough Attorney for his legal opinion; if we were now to have the signs removed and then there was an incident after the police recommended that signs be placed. Mayor said that there are many side streets along that Washington Road corridor and this one has been singled out. He said that he would like the residents input.

The Borough Attorney indicated that inasmuch as we have a report from the police department indicating that it is unsafe. If someone were to be injured for whatever reason, it would be most likely that the attorney would file a Tort Claims Notice upon the Borough that the Borough knew this. The Police Department made a recommendation and the Borough did x,y&z. The Borough would probably get a Tort Claims Notice.

Councilwoman Novak said that when she drives the ambulance and was involved in a case where they hit one of the parked cars, trying to get the ambulance down the street when parking was allowed on both sides of the street and now these ambulances are much wider than they used to be and she took out the side of a car because there was parking on both sides of the street and it was impossible to pass and to get to the cardiac arrest patient, she had to hit the car. Mr. Kurczeski said a garbage truck could get down his street.

Councilwoman Novak asked the Mayor if Keven Krushinski could come up and speak on this matter. Mr. Krushinski said that he is the Assistant Fire Chief and the Fire Marshall. And after receiving a complaint about the way the vehicles park along Pershing Avenue. He said that it was like threading a needle the way the vehicles are parked along the road he talked about the size of a parking lane, width of an average vehicle and the width of the roadway and the size of a fire

truck. That the truck would not fit to put out a fire, so that is the basis as to why he made the recommendation he did and that the no parking was for the side of the street that would only affect three homes.

Mayor asked that these issues be brought up at the committee meeting with the residents.

Council President Kilpatrick again brought up the issue that after all of these safety issues have been brought up, if there would be even more of a legal issue if the signs get removed.

The Borough Attorney stated that additional Tort Claims could be filed because of the heightened risk brought out by our professionals. She then said now that we have heard from the professionals that the discussion should be what side of the street we should make No Parking.

Councilman Grillo asked what would have happened if Mr. Kurczeski Sr. had a dedicated handicapped space in front of his home. Councilwoman Novak the Police Traffic bureau never recommends this when there resident has a driveway.

More discussion between the council and the resident and Fire Official.

Council President Kilpatrick stated that before policy gets changed that they get input from the Traffic Safety Bureau, the Fire Department..... Mayor asked that Mr. Kurczeski meet with the committee and the Fire Marshall and Police Traffic Safety and discuss the matter and come up with a solution.

- Phil Emma, Parlin

Questioned what is happening with the marijuana committee.

Councilman Buchanan responded that the sub-committee met and are working on some ideas however they are still waiting for the Statute. He said he has asked the Assembly Speaker's office and they said that it can't be released yet because they are still working on it. He said that he reached out to the gentleman from the Woodbridge dispensary to get an idea on how it operates and looks like and they never returned the call. Councilman Grillo said they are trying to access the different variations they would have to address on all areas. Adult dispensaries, grow houses, bud bars - need to see what the Statute is going to allow. At this point they do not have enough of information to make a decision. At this point we need to have another public meeting. Councilman Buchanan said that they want to make sure everything is addressed in this ordinance and that it is in line with the State Statute. Councilman Lembo said that he also tried reaching out to the dispensary and no one answers or responds.

Mr. Emma questioned the mission of the committee.

Councilman Lembo said that after meeting they are waiting to see what the State says. Nothing is etched in stone yet, they need the bill.

Mr. Emma asked that they have an ordinance right now prohibiting recreational marijuana just as the Police Chief had recommended because it would affect our quality of life and public safety.

Councilwoman Novak said that the Chief had asked for a resolution and that such a resolution basically bears no weight. For an ordinance we need a complete ordinance, one that would be legally defensible in court. Councilman Lembo expressed how he does not want to see recreational marijuana in Sayreville but he does not object to medical marijuana.

The Borough Attorney said that they want to draft an ordinance that would survive a challenge. The committee also asked for the input from the planner regarding the zoning aspect. He explained that this is in no way a stall tactic. He further explained what other towns have done. Certain ordinances would be preempted by State law, so at this point they do not want to create paperwork that may not survive a challenge to the State law, they want to get it right the first time.

Mr. Emma read an article from USA Today regarding the teen use of marijuana and its effects, etc.

Discussion continued regarding the law and how complicated it is and how this council wants to get it right.

- Jim Robinson, 11 Borelle Square

Thanked the Council for approving Resolutions #2018-348, 349, 350 and 351. He then asked the Mayor if he was going to sign the Resolutions. Mayor O'Brien indicated that he had not read in yet. Mr. Robinson stated that the Clerk read it in full. Mayor indicated that he wanted to go over it again.

Mr. Robinson asked how much property was involved in the transfer in Resolution 2018-349 and about the compensation? Councilwoman Novak stated that it was a little less than 1 acer. Council President Kilpatrick said that by the Judges orders the Borough would have to pay the attorney fees.

Mr. Robinson asked if the Public Safety Committee should be the one addressing Mr. Kurczeski's parking concerns? Council President said that he was correct. He also asked if the Mayor can appoint.

Mr. DuPont said that he can with the advice and consent of the Council.

Mr. Robinson then asked what the status was on the potential senior housing on Ernston Road. The one that the Housing Authority has recommended.

Councilwoman Novak said that is being considered in the next round of our housing obligation.

Mr. Robinson again asked the Mayor if he signed the resolution and that if he does not sign it the Council President will.

Commented that people are complaining about not hearing council meetings on television.

Spoke about committee assignments.

Asked the Council to pass a Resolution opposing marijuana in Sayreville and send it to the legislature.

Councilwoman Novak said that she agreed with sending a resolution to our legislature telling them that they are not in favor of it for recreational use. But they must take their time on the Ordinance in order to get it right. Councilwoman Kilpatrick felt the same. Councilwoman Novak asked if the Attorney could compose a resolution for the next meeting. There was no opposition to the resolution.

Councilman Grillo asked Mr. Olchaskey if he could send the Business Administrator or clerk a copy of the Ernston Rd. Sr. Project. He would like to see it again.

Asked if anyone looked into the North Ernston Road/Chase Bank traffic issue.

Mr. Frankel said that the Police Chief gave it to the traffic bureau and he did not get a reply yet.
