RESOLUTION APPROVING COUNTY UTILITY AGREEMENT BETWEEN THE BOROUGH OF SAYREVILLE AND THE COUNTY OF MIDDLESEX FOR WATER LINE IMPROVEMENTS

WHEREAS, the Borough of Sayreville ("Borough") is located in the County of Middlesex, State of New Jersey; and

WHEREAS, the County of Middlesex ("County") has determined that it is necessary to make improvements within its existing right-of-way located at the intersection of Jernee Mill Road and Bordentown Avenue within the Borough; and

WHEREAS, the Borough owns and maintains a ten (10) inch water line and a sixteen (16) inch water line along Jernee Mill Road within the County's existing right-of-way; and

WHEREAS, as part of the improvements that the County is proposing within its existing right-of-way at the intersection of Jernee Mill Road and Bordentown Avenue, the Borough's existing ten (10) inch water line will be extended to connect to the Borough's existing sixteen (16) inch water line in order to eliminate a dead-end condition; and
