ORDINANCE #23-24 BOROUGH OF SAYREVILLE COUNTY OF MIDDLESEX AN ORDINANCE REGULATING REMOVAL OF GARBAGE, REFUSE AND RUBBISH IN THE BOROUGH OF SAYREVILLE, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

WHEREAS, the Board of Health of the Borough of Sayreville ("Borough") has recommended the Borough Council regulate the removal of garbage, refuse, and rubbish within the Borough; and

WHEREAS, the Borough desires to set forth an ordinance that regulates the removal of garbage, refuse, and rubbish to preserve public health, safety and general welfare of the citizens of the Borough; and

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Sayreville in the County of Middlesex, State of New Jersey, as follows:

SECTION 1. <u>Definitions</u>. Whenever used in this Ordinance unless a different meaning clearly appears from the context:

- A. <u>Building</u> shall mean any premises occupied by commercial, industrial, or residential tenants.
- B. Borough shall mean the Borough of Sayreville.
- C. <u>Garbage</u> shall mean putrescible animal or vegetable wases from the handling, preparation, cooking, and consumption of food.
- D. <u>Refuse</u> shall mean all putrescible and non-putrescible solid wastes (except body wastes) including cans, glasses, bottles, concrete, household sweepings, and other items of a similar facsimile, usually non-combustible.
- E. <u>Rubbish</u> shall mean non-putrescible solid wastes, including paper, cardboard, excelsior, straw boxes, crates, garden and lawn clippings, wood, and materials of a similar facsimile, usually of a combustible nature.
- F. <u>Hazardous Materials</u> shall mean those materials requiring special handling techniques due to the potential dangers caused by their inherent toxicity, breakage, consumption, and/or illegal use, i.e. paints, chemicals, hydrocarbons, and/or their derivatives, refuse pharmaceuticals and discarded syringes, cathode ray tubes, fluorescent bulbs, etc.

SECTION 2. <u>Disposal</u>. No person shall dispose of, deposit, or throw garbage, refuse, or rubbish or any other material upon or along any public or private highway, road, or street, or upon public or private property or any river, stream or body of water within the Borough.

SECTION 3. Responsibility of Owner. In any building occupied by more than one tenant, the owner and tenants shall be jointly and severally responsible to keep all common areas of the property and premises free of garbage, refuse, or rubbish, and to see that proper receptacles are used, placed on the curb, and removed as so required, and that all other provisions of this Ordinance are conformed to.

SECTION 4. Free Premises. All owners of vacant lots or abandoned buildings shall keep the premises free from garbage, refuse, or rubbish.

SECTION 5. <u>Hazardous Materials</u>. Hazardous materials, as defined by this Ordinance, shall not be placed in receptacles, but shall be removed by appointment through special collection. All hazardous materials shall be securely wrapped and tied to prevent breakage.

SECTION 6. Conflicts. All Ordinances of the Board of Health or the Borough of Sayreville or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, it being legislative intent that all Ordinances or parts of Ordinances now existing or in effect, unless the same be in conflict or inconsistent with any provisions of this Ordinance, shall remain in effect.

SECTION 7. Severability. The provisions of this Ordinance are declared to be severable and if any section, sub-section, sentence, clause, or phrase thereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sib-sections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION 8. Penalties. Any person, firm, or corporation who shall violate any of the provisions of the Ordinance shall, upon conviction, be punished by a fine of not to exceed five hundred dollars (\$500.00) or by imprisonment for a period not to exceed ninety (90) days, or by such fine and imprisonment, and each violation of any of the provisions of this Ordinance and each day there is a violation thereof shall be deemed and taken to be a separate and distinct offense.

SECTION 9. Enforcement. The Construction Official and the Health Official, or their agents, are empowered to notify any owner of lands within the Borough to remove any and all of the items enumerated in this Ordinance. Notice shall be given to the owner by certified mail, return receipt requested, at the owner's last known address. A minimum of five (5) days shall be given for abatement of violations.

SECTION 10. Removal by Borough. In the event the owner, tenant, or person in possession of the lands in question shall refuse or neglect to abate or remedy the condition which is in violation of this section within ten (10) days after receipt of notice, the Construction Official or Health Official, or their agents, shall cause the same to be abated and remedied and certify the costs thereof to the Council, who shall examine the certificate and, if found correct, cause the costs as shown thereon to be charged against the lands. The amount so charged shall forthwith become a lien upon such lands and shall be added to and become and forma a part of the taxes next to be assessed and levied upon such lands, the same to bear interest at the same rate as taxes, which shall be collected and enforced by the same officer and in the same manner as taxes. Costs shall be in addition to any penalties imposed for a violation of this section.

SECTION 11. Effective Date. This Ordinance shall take effect upon passage and publication as provided by law.

ORDINANCE #27-24 BOROUGH OF SAYREVILLE COUNTY OF MIDDLESEX ORDINANCE REGARDING TOTALLY DISABLED VETERAN'S TAX EXEMPTION

SECTION 1. Chapter XXXIII, entitled "Tax Exemptions and Abatements" is hereby amended and supplemented as follows:

§ 33-11 Totally Disabled Veteran's Tax Exemption.

- a. The Borough of Sayreville will allow for either a veteran or surviving spouse of a veteran to obtain municipal property tax relief upon proper claim. An eligible veteran shall be defined as a member of the armed forces who was either honorably discharged or released under honorable circumstances from active military service in the time of war or has been declared by the United States Veterans Administration to be One Hundred (100%) percent, permanently and totally disabled.

BOROUGH OF SAYREVILLE COUNTY OF MIDDLESEX ORDINANCE REGARDING ENVIRONMENTAL COMMISSION

WHEREAS, the Borough of Sayreville ("Borough") created an Environmental Commission pursuant to N.J.S.A. § 40:56A-1 to 50:56A-7; and

WHEREAS, the Borough seeks to clarify the membership of the Environmental Commission and its powers and duties.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Sayreville, in the County of Middlesex and the State of New Jersey, as follows:

SECTION 1. Chapter II, entitled "Administration" is hereby amended and supplemented as follows:

§ 2-32 Environmental Commission.

§ 2-32.2 Members.

A Commission shall consist of seven (7) members appointed by the Mayor with the advice and consent of the Borough Council, for a three (3) year term, one (1) of whom shall also be a member of the Planning Board and all of whom shall be residents of the Borough. The members shall serve without compensation except as hereinafter provided. The Commission shall annually, upon reorganization, elect a Chairman from within. There shall, in addition, be appointed two (2) alternates to serve on said board. Each said alternate to be designated as Alternate 1 and Alternate 2 to serve for three (3) year terms. In addition to the foregoing, the Commission shall include two (2) student representatives from the Sayreville War Memorial High School.

The Borough Council may remove any member of the Commission for cause, on written charges served upon the member and after a hearing thereon at which the position shall be filled for the unexpired terms in the same manner as an original appointment.

§ 2-32.3 Powers of Commission.

The Commission shall have the following powers:

- a. The promotion of the conservation and development of all the natural resources of the Borough.
- b. Plan, inform and recommend to the Borough and to the public local conservation programs.
- c. Implement conservation programs as authorized by the Borough Council.
- d. Compile and keep an index of all open areas, publicly or privately owned, including open marshlands, swamps and other wetlands.
- <u>d.</u> e. The power to conduct research into the possible use of the open areas of the Borough.
- e. f. Recommend to the Planning Board plans and programs for inclusion in a municipal master plan and the development and use of such areas.
- g. Advertise, prepare, print and distribute books, maps, charts, plans and pamphlets, which in its judgment it deems necessary for its purposes.

- h. Act as the coordinating agency of the community on conservation needs and regional, State and Federal agencies ministering to those needs.
- g. i. To study and make recommendations concerning open-space preservation, water resources management, air pollution control, solid waste management, noise control, soil and landscape protection, environmental appearances, Marine resources and protection of fauna and farm.

§ 2-32.4 Acquisitions by Commission.

The Environmental Commission may, subject to the approval of the Borough Council, acquire property, both real and personal, in the name of the Borough by gift, purchase, grant, bequest, device or lease for any of its purposes and shall administer the same for such purposes subject to the terms of the conveyance or gift. Such an acquisition may be to acquire the fee or any lesser interest, development right, easement (including conservation easement), covenant or other contractual right (including a conveyance on conditions or with limitations or reversions), as may be necessary to acquire, maintain, improve, protect, limit the future use or otherwise conserve and properly utilize open spaces and other land and water areas in the Borough.

§ 2-32.5 Records and Annual Report.

The Commission shall keep records of its meetings and activities and shall make an annual report on or before the first day of February and submit the same to the Council of the Borough, which report shall be comprehensive and detailed covering operations, receipts, disbursements and expenditures for the full year.

WHEREAS, the Borough of Sayreville ("Borough") is governed under the Borough form of government pursuant to N.J.S.A. 40A:60-3 et seq; and

WHEREAS, the Borough Council meets twice each month, and at such other times as may be necessary at Borough Hall or another Borough location; and

WHEREAS, the Borough Council intends that its regular meetings be governed by uniform rules of parliamentary procedure, and which are currently governed by Rules of Order that do not address all aspects of parliamentary procedure; and

WHEREAS, the latest revised edition of Robert's Rules of Order serves as the basis for comprehensive parliamentary procedure during the meetings of governing bodies in a number of municipalities throughout New Jersey; and

WHEREAS, the Borough Council seeks to apply the latest revised edition of Robert's Rules of Order to its deliberations.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Sayreville in the County of Middlesex, State of New Jersey, as follows:

SECTION 1. Chapter II of the Code of Ordinances, titled "Administration" is hereby amended as follows:

§ 2-3 - Meetings.

2-3.2 Order of Business.

At all regular meetings, the deliberations of the Borough Council shall be governed by law and the rules of procedure shall be in accordance with the latest revised edition of Robert's Rules of Order, except that, by majority vote, the Borough Council may elect to set aside procedural rules, provided such setting aside is not in conflict with statutory requirements, and provided also that the setting aside will expedite the Borough Council's work or further public understanding of the issues at hand. The business of the Council shall be taken up for consideration in substantially the following order except as may be otherwise ordered by the Mayor and Council:

- a. Roll call.
- b. Presentment of ordinances for final approval.
 - I. Old Business: Ordinances subject to final approval
 - i. Public Portion on ordinances subject to final approval
 - ii. Optional Council comments
 - II. New Business: Introduction of new ordinance(s)
 - i. Presentation and/or discussion at introduction, (optional)
 - A. Person running meeting will designate speaker.
 - ii. Public portion to take place at subsequent meeting when ordinance is presented
- c. Communications as set forth on agenda.
- d. Public hearings on agenda resolutions only.
- e. Consent agenda resolutions by roll call.
- f. Resolutions to be read in full.
- g. Resolution to approve or disapprove list of vouchers and claims.
- h. Committee reports.
- i. General discussion items
- j. Public portion
 - a. Optional council response
- k. Executive Session, (as needed)
- l. Adjournment

During the public hearings set forth above, it shall be the policy of the Mayor and Borough Council that all speakers from the public shall be recognized to speak up to five (5) three (3) minutes in total at one time in order to provide an opportunity for everyone to speak. Members of the public may be recognized more than once at said public hearings at the sole discretion of the presiding officer provided that all members of the public wishing to speak shall be recognized prior to the members of the public being called upon for a second or subsequent period of time, and that no member of the public's total time exceeds five (5) minutes.

The provisions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to the portion of the Ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.

CONDITIONS ON P.R.C.L. #1219-33-058-008 PURE EVENT CENTER, INC.

- 1. Licensee shall strictly enforce a policy that patrons who have been admitted to enter the Licensed Premises who subsequently exit the Licensed Premises will not be permitted to re-enter the Licensed Premises on the same day/evening. This measure is intended to address the Mayor and Council's previous finding that drug activity was noted on the Licensed Premises and in recognition of the fact that a practice of allowing patrons to exit and then re-enter the Licensed Premises facilitates drug activities by providing an opportunity for such persons to retrieve contraband from their vehicles for use and/or distribution inside and adjacent to the Licensed Premises. all such litter, trash and other discarded items as my be generated by and/or associated with Licensee's operation. To the extent that residents within such five hundred (500) foot radius consent to permit access to private property for the purposes of such cleaning on private property, Licensee shall cause such private property to be cleaned of all litter, trash and other discarded items, at Licensee's sole cost. This measure is designed to alleviate any problem associated with the accumulation of empty beverage containers, cans, bottles and other debris that results from the operation of the Licensed Premises.

- 4. Licensee shall construct and maintain an 8' high solid fence at the rear property line mandated by the Planning Board Resolution dated March 2, 2016, before conducting any public event.
- 5. Licensee shall install "zero tolerance" signs inside the Licensed Premises, at or adjacent to the entry to the premises, containing language indicating that patrons will be prosecuted to the fullest extent of the law for any possession, sale or distribution of any drug, controlled substance or drug paraphernalia. This measure is designed to discourage drug activity occurring at or on the Licensed Premises.
- 6. Licensee shall install soundproofing equipment and/or take any other necessary steps to limit the escape of sound and vibration from the Licensed Premises, sufficient to ensure that no audible sounds is transmitted beyond the property line of the Licensed Premises. This measure is designed to alleviate concerns regarding noise levels as recounted from complaint received by members of the Council pertaining to the Licensed Premises.
