**A RESOLUTION OF THE SAYREVILLE ECONOMIC AND REDEVELOPMENT
AGENCY ESTABLISHING EMPLOYEE SALARIES**

WHEREAS, pursuant to amended By-Laws of the Sayreville Economic and Redevelopment Agency (the "Agency") adopted on January 25, 2024, the Agency establish employee salaries for calendar year 2025; and

NOW, THEREFORE, BE IT RESOLVED, by the Sayreville Economic and Redevelopment Agency that the officers for the Agency for calendar year 2025 shall be:

BE IT FURTHER RESOLVED, that the Agency Commissioners hereby appoint Himanshu Shah as Executive Director of the Agency, on a part-time basis and as an employee of the Agency with no benefits, for calendar year 2025 based on an annual salary of \$100,000; and

BE IT FURTHER RESOLVED, that the Agency Commissioners hereby appoint Wayne Kronowski as Chief Financial Officer of the Agency, on a part-time basis and as employee of the Agency with no benefits, for calendar year 2025 based on an annual salary of \$40,000; and

BE IT FURTHER RESOLVED, that the Agency Commissioners hereby appoint Sujata Salian as Account Clerk, on a part-time basis and as employee of the Agency with no benefits, for calendar year 2025 based on an annual salary of \$7,200 (\$600 a month); and

BE IT FURTHER RESOLVED that the Chairperson and Agency Professionals are hereby authorized and directed to take any action and to execute any documents as may be necessary to effectuate this Resolution.


